 - D. Approval of Minutes
 - E. Approval of the Agenda
 - F. Open Forum
 - G. Special Event-determined by Chair and if necessary
 - H. Communications president, vice president, etc.
 - I. Ex-Officio Communications
 - J. Committee Reports--Steering first, followed by others in alphabetical order
 - K. College Contact Reports
 - L. Old Business
 - M. New Business
 - N. Announcements
 - O. Processing
 - P. Adjournment
