Title: ASUW Juried Exhibition

- 1. WHEREAS, the Associated Students of the University of Wyoming (ASUW)
- 2. 2004 Summer Report identifies a student art competition for the purpose of
- 3. decorating the ASUW office as a 2004-2005 goal; and
- 4. WHEREAS, the artistic talents of UW students, rather than the talents of non-
- 5. fee paying and/or professional artists, should be showcased on the walls of the
- 6. ASUW office; and
- 7. WHEREAS, the artists should be compensated for the cost of their materials
- 8. and time; and
- 9. WHEREAS, artists in the industry are regularly asked to compete in
- 10. competitions known as juried exhibitions.
- 11. THEREFORE, be it enacted that the Associated Students of the University
- 12. of Wyoming sponsor a juried exhibition in the spring of 2005 for the purpose
- 13. of decorating the ASUW office; and
- 14. THEREFORE, be it further enacted that the theme of the juried exhibition be
- 15. "Wyoming Through Your Eyes"; and
- 16. THEREFORE, be it further enacted that the exhibition will be open to all UW
- 17. students; and
- 18. THEREFORE, be it further enacted that the juried exhibition will follow the

- 19. guidelines set forth in Addendum A; and
- 20. THEREFORE, be it further enacted that \$3,000 be earmarked from end-of-
- 21. year funds to purchase the artwork from the Juried Exhibition; and,
- 22. THEREFORE, be it further enacted that because the student winners will have
- 23. already been notified of their award status, purchasing the artwork from the
- 24. Juried Exhibition be the first priority of the new Presidential and Vice-
- 25. Presidential team when utilizing end-of-year funds; and
- 26. THEREFORE, be it further enacted that ASUW will spend no more than
- 27. \$3,000 on artwork that meets ASUW's expectations; and
- 28. THEREFORE, be it further enacted that in the event that the full \$3,000 is not
- 29. spent, any remaining funds will remain with the end-of-year monies.

Addendum A

CALL FOR ARTISTS

"WYOMING THROUGH YOUR EYES"

A Juried Exhibition Sponsored by: **ASUW**

ASUW is sponsoring a juried exhibition open to all University of Wyoming students. The purpose of this show is to acquire student artwork to be permanently showcased in the ASUW office. The guidelines of the show are as follows:

- Artists will submit four slides of their work pertaining to the theme "Wyoming Through Your Eyes" to Bob Sell, Campus Activities Center, by March 28, 2005.
 - Artists will complete an application form, providing information such as the artist's name, title of the artwork, price of the artwork, contact information, medium and dimensions of artwork. The application will be approved by Jessi Steward before circulation to ensure all pertinent information is gathered.
- A seven-member panel will review the slides and select its choice(s) for display in the ASUW office.
 - o The panel will consist of:
 - Richard Stegman, UW Dean of Students
 - Bob Sell, Wyoming Union Program Advisor
 - Jessi Steward, Wyoming Union Coordinator, Conferences & Marketing
 - Representative from ASUW Judicial Council
 - Representative of the ASUW Executive Branch
 - Clayton Elliott, ASUW Freshman Senate
 - ASUW Senate
 - Senate will get one collective vote on the Board
 - All slides will be shown during a special event at a regular ASUW meeting
 - Each senator will vote for their top 3 choices of artwork to be purchased. Votes will be tallied and the piece with the most votes will receive one vote from Senate
- It will be the objective of ASUW to purchase a minimum of four pieces of student artwork. However, ASUW reserves the right not to purchase any art, if none of the pieces submitted meet its expectations. A maximum of \$3000 will be earmarked from end-of-year funds to purchase the artwork from the Juried Exhibition. Because the student winners will have already been notified of their award status, purchasing the artwork from the Juried Exhibition will be the first priority of the new Presidential and Vice Presidential team when utilizing end-of-year funds. In the event that the full \$3,000 is not spent, any remaining funds will remain with the end-of-year monies.

- All slides become the property of ASUW unless the applicant provides a self-addressed, stamped envelope with the application.
- Artists will be notified of their award status by April 19, 2005.
- The artwork will be on permanent display in the ASUW office no later than Fall 2005.
