- 1. WHEREAS, the mission of the Associated Students of the University of
- 2. Wyoming (ASUW) is to serve its fellow students in the best manner possible
- 3. through accurate representation, professional interaction with campus programs
- 4. and organizations, and responsible, effective leadership; and
- 5. WHEREAS, ASUW collects a student fee to administer the programs and
- 6. services of ASUW to fund the governing boards of the ASUW Student
- 7. Government, and to support Recognized Student Organizations.
- 8. THEREFORE, be it enacted by the Associated Students of the University of
- 9. Wyoming (ASUW) Student Senate that the budget of ASUW, its contingencies,
- 10. and all parts thereof for Fiscal Year 2008 be approved as allocated from the
- 11. following sources: \$836,200 from the ASUW Fees; \$70,437 from the ASUW
- 12. Reserve: \$40,000 from the ASUW Endowment; \$55,000 from the ASUW
- 13. scholarship endowments; \$23,407 from the ASUW Equipment Reserve;
- 14. \$21,000 from the Concert and Convocation Reserve; and \$71,900 from other
- 15 revenues; and
- 16. THEREFORE, be it further enacted that the total budget for Fiscal Year 2008
- 17. shall be \$1,117,944; and
- 18. THEREFORE, be it further enacted by the ASUW Student Senate that the

- 19. logistics of administering this budget, which utilizes funds from the ASUW
- 20. Fees, the ASUW Reserve, the Concert and Convocations Reserve, the ASUW
- 21. Endowment, the ASUW scholarship endowments, the ASUW Equipment
- 22. Reserve, and other revenue accounts, be under the direction of the ASUW
