- 1. WHEREAS, the mission of the Student Government of the Associated Students of the
- 2. University of Wyoming (ASUW) is to serve its fellow students in the best possible manner
- 3. through accurate representation, professional interaction with campus programs and
- 4. organizations, and responsible effective leadership; and,
- 5. WHEREAS, to this end, ASUW annually collects and dispenses student fee monies for the
- 6. purpose of the support of the ASUW, its various programs, and Recognized Student
- 7. Organizations; and,
- 8. WHEREAS, certain programs and services of ASUW need specific attention and an
- 9. individual budget; and,
- 10. WHEREAS, the needs and wants of all ASUW entities were assessed by the ASUW Budget
- 11. and Planning Committee in accordance with the ASUW Finance Policy; and,
- 12. WHEREAS, ASUW will receive a programmatic student fee increase in Fiscal Year 2015
- 13. (FY2015), pursuant to the recommendation of the ASUW Budget and Planning Committee,
- 14. the ASUW Student Fee Committee, and the decision of the University of Wyoming Board of
- 15. Trustees; and,
- 16. WHEREAS, ASUW programs and services are constantly growing and improving.
- 17. THEREFORE, be it enacted by the Student Senate of the Associated Students of the



18. University of Wyoming (ASUW) that the budget of ASUW, its contingencies, and all parts
19. thereof be approved as allocated from the following sources for Fiscal Year 2015 (FY15):
20. \$680,435.60 from the ASUW Academic Year fees; \$52,800.00 from the ASUW Summer
21. Fee; \$11,000.00 from the ASUW Reserve; \$87,500.00 from various ASUW endowments;
22. \$6,400.00 from the ASUW Equipment Reserve; and \$8,200.00 from other revenues; and,
23. THEREFORE, be it further enacted that the total budget for FY15 shall be \$846,355.60, as
24. allocated in Addendum A; and,
25. THEREFORE, be it further enacted that the logistics of this budget, which utilizes monies
26. from the ASUW Fees, the ASUW Reserve, the ASUW Special Projects Endowment, the
27. various ASUW Scholarship Endowments, the ASUW Equipment Reserve, and other ASUW
28. revenues, be under the discretion of the Dean of Students or designee and the ASUW Budget
29. and Planning Committee in accordance with the ASUW Finance Policy.
