- 11. WHEREAS, the current obligations of Senators of the ASUW Student Government as

Addendum A

Article II

Section 4. Senate Authority and Responsibilities:

- K. ASUW senators shall have the following standardized physical responsibilities:
 - i. Senators shall attend regularly scheduled meetings of the ASUW Student Senate, and any special meetings of the ASUW Student Senate as scheduled by the ASUW Vice President.
 - ii. Senators shall serve on a minimum of two (2) ASUW Standing Committees.
 - iii. ASUW Senators shall make a presentation, each semester, to a class chosen from a list compiled by the ASUW Vice President.

 Failure to complete this requirement will result in an automatic referral to the ASUW Steering Committee.
 - iii. Each full month of the academic semester, senators will be required to accumulate four (4) service hours. Service hours can be accumulated through the following means:
 - a. Documented office hour in the ASUW office.
 - b. Documented participation in an ASUW student outreach event.
 - c. Documented attendance or participation in an ASUW funded event.
 - d. Documented volunteering with an ASUW program.
 - e. Any other form of service hour, as pre-approved in writing by the ASUW Vice President, with the subsequent approval of the ASUW Steering Committee.
