- 2. (ASUW) Student Government to serve our fellow students in the best manner possible
- 3. through accurate representation and responsible, effective leadership; and,
- 4. WHEREAS, the President of the ASUW Student Government has the authority to appoint
- 5. officials to the Executive Branch at her/his discretion with the approval of the Senate body;
- 6. and,
- 7. WHEREAS, the structure and composition of the Executive Branch may vary among
- 8. administrations; and,
- 9. WHEREAS, the ASUW Student Government aims to mirror local, state, and federal
- 10. governments in their structure and system of checks and balances; and,
- 11. WHEREAS, an effective system of checks and balances relies heavily on equal separation of
- 12. powers and responsibilities within each branch; and,
- 13. WHEREAS, the ASUW By-Laws outline the responsibilities of the ASUW President
- 14. but are ambiguous in defining the roles of the Executive Branch as a whole; and,
- 15. WHEREAS, the primary purpose of the Executive Branch as a whole is to assist the
- 16. ASUW President, Vice President and Senate in programs and objectives of the ASUW
- 17. and to implement actions voted upon by the Legislative Branch; and,
- 18. WHEREAS, the Legislative Branch of the ASUW Student Government is comprised of



- 19. thirty (30) students, elected by constituents of their respective colleges; and,
- 20. WHEREAS, the primary duty of the Legislative Branch of the ASUW is to represent
- 21. University of Wyoming students through the formation and enactment of legislation in the
- 22. form of bills or resolutions; and,
- 23. WHEREAS, in order to enact appropriate and effective legislation, there is a need to foster
- 24. transparency and communication between the Executive and Legislative Branches.
- 25. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
- 26. (ASUW) Student Government that the ASUW Rules and Procedures be amended to reflect
- 27. the changes outlined in Addendum A; and,
- 28. THEREFORE, be it further enacted that the ASUW By-laws be amended to reflect
- 29. the changes outlined in Addendum B; and,
- 30. THEREFORE, be it further enacted that these changes go into effect at the start of the
- 31. 104th Administration of the ASUW Student Government.

Addendum A

ARTICLE VI

Legislative Action

Section 1. Legislative Process

A. Bills and resolutions may be submitted by any fee-paying student. All bills and resolutions must be sponsored by no less than two (2) Senators of the ASUW Senate or by an ASUW standing committee. Authors may sponsor their own legislation but then must have at least two additional Senator sponsors. Members of the Executive Branch other than the President or Vice President may author legislation but must have at least one (1) Senator of the Legislative Branch or a Student-at-Large (SAL) as a co-author. Regardless of their fee paying student status, members of the Judicial Council may not author or sponsor legislation due to their association.

Addendum B

ARTICLE I

Executive Branch

Section 5. Members of the Executive Branch may have the authority to author legislation, authors who are members of the Executive Branch who are not the President or the Vice President may only do so if the effort is in collaboration, resulting in coauthorship, with at least one (1) Senator of the Legislative Branch or a Student-at-Large (SAL).
