TITLE: Special Project Allocations for Fiscal Year '17

DATE INTRODUCED: November 15, 2016

AUTHOR: ASUW Budget and Planning Committee

SPONSORS: Senators Dooley and Drake



1. WHEREAS, the Associated Students of the University of Wyoming (ASUW) Student
2. Government allocated \$75,000 to be expended in Fiscal Year '17 for Special Projects; and,
3. WHEREAS, the ASUW Finance Policy states "The ASUW Special Projects Endowment may
4. be used for one-time projects that will benefit a large population for several years"; and,
5. WHEREAS, the ASUW Budget and Planning Committee has reviewed applications,
6. researched the viability, and determined which proposals meet the specific guidelines; and,
7. WHEREAS, the ASUW Finance Policy dictates that the allocation and announcements of
8. Special Projects Endowment expenditures be made prior to the conclusion of the Fall
9. Semesters.
10. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
11. (ASUW) Student Government that \$74,955.46 be allocated from the Special Projects
12. Endowment as outlined in Addendum A.

In looking at the Special Project from the Outdoor Program, the paddleboards have been asked by a significant number of students over the past couple years. These paddleboards will also last several years due to the durability of these items.

Applicant: Potter Law Club

The Potter Law Club is requesting a new larger fridge for the common area used by all Law Students, this area is used by students to store lunches and dinners. Currently it's at capacity. Also a part of the request is installing a water fountain in the basement of the law school. Currently there is not one, and a good majority of students have study carrels there.

Applicant: ASUW Programming Committee

Four tents in total, two with the ASUW logo and the other two with the ASTEC logo. These come out in total \$4,137.46. These are important to help keep ASUW and ASTEC able to outreach to as many students as possible even with poor weather. It will also help protect ASTEC's equipment while doing outdoor events.

Applicant: ACRES Student Farm

ACRES is requesting new hosing to increase the ability to water various sections of the farm. Currently these areas are being watered by hand and/or weak irrigation due to water pressure issues.

Applicant: ASTEC

ASTEC is requesting a variety of equipment aimed at increasing their capacity to handle multiple student events at a time. These range from cables to light elements. ASTEC is required to adapt to the needs of each event located in drastically different locations across campus.
