1. WHEREAS, it is the purpose of the Associated Students of the University of Wyoming

- 2. (ASUW) Student Government to effectively represent the needs of students on the
- 3. University of Wyoming (UW) campus; and,
- 4. WHEREAS, ASUW programs were established to provide representation and
- 5. services to students on the UW campus through funding from student fees; and,
- 6. WHEREAS, the ASUW Student Government acknowledges that Recognized Student
- 7. Organizations (RSOs) also provide unique activities and experiences for students; and,
- 8. WHEREAS, ASUW programs are required and RSOs are encouraged to use UW Catering
- 9. for events that provide food within the Wyoming Union; and,
- 10. WHEREAS, UW Catering currently does not have a structured procedure or timeline to
- 11. process and answer catering requests; and,
- 12. WHEREAS, there is currently no accessible system to give feedback concerning the quality
- 13. of services provided by UW Catering; and,
- 14. WHEREAS, numerous events were hosted by RSOs and ASUW Programs at the
- 15. Wyoming Union during the 2015-2016 academic year; and,
- 16. WHEREAS, in light of the current financial crisis faced by UW, RSOs and ASUW Programs

- 17. must strategically spend their budget to accommodate the most students as possible; and,
- 18. WHEREAS, due to the financial crisis, the ASUW Student Government's RSO Funding
- 19. Board has become a main source for event funding; and,
- 20. WHEREAS, Article III, Section XXI of the ASUW Finance Policy states that ASUW will
- 21. fund catering for events up to \$18 per expected student.
- 22. THEREFORE, be it resolved by the Associated Students of the University of Wyoming
- 23. (ASUW) Student Government that the ASUW Student Government supports the creation of a
- 24. budget-friendly student menu by UW Catering for ASUW Programs and RSOs to use for
- 25. events; and,
- 26. THEREFORE, be it further resolved that the ASUW Student Government supports a
- 27. collaboration between the ASUW Student Government and UW Catering to establish a
- 28. system for UW Catering to receive feedback on events hosted by ASUW Programs and
- 29. RSOs; and,
- 30. THEREFORE, be it further resolved that the ASUW Student Government supports a
- 31. collaboration between the ASUW Student Government and UW Catering to establish a clear
- 32. and concise timeline and procedure for ASUW Programs and RSOs to requests services by
- 33. UW Catering.
- 34. THEREFORE, be it further resolved that the ASUW Student Government recommends that
- 35. the ASUW Vice President establish an Ad-hoc committee to continue working towards
- 36. addressing the catering concerns in this legislation, including members from PID and SOP
- 37. committees, ASUW Senate, and the larger student body.
