1. WHEREAS, the purpose of the Associated Students of the University of Wyoming (ASUW)

2. Student Government is to serve our fellow students in the best manner possible through

3. accurate representation and professional interaction with campus programs and

4. organizations; and,

5. WHEREAS, the ASUW 2014-2018 Strategic Plan outlines the responsibility of the ASUW

6. Student Government to identify ways to connect University of Wyoming (UW) students and

7. alumni to their institution; and,

8. WHEREAS, a duty of ASUW Student Government is to reflect and communicate the values

9. and opinions of the students they represent; and,

10. WHEREAS, art displayed on the UW campus may be seen as a nonverbal representation of

11. campus values and opinions; and,

12. WHEREAS, art displayed on the UW campus can be a way students, alumni, and members

13. of the campus community connect and identify with the institution; and,

14. WHEREAS, the city of Laramie has recognized the significance of public art and published a

15. comprehensive plan detailing the development and community approval of art in the city of

16. Laramie; and,

17. WHEREAS, the UW is currently without a similar or comprehensive plan to review and

18. establish the installation of art on campus; and,



- 19. WHEREAS, the President's Public Art Committee's stated mission statement is to seek to
- 20. enrich the cultural, intellectual, and scholarly life of the University of Wyoming's students,
- 21. faculty, staff, and visitors while advancing the university's academic mission through
- 22. enhancing and complimenting the physical and aesthetic environment of campus, preserving
- 23. and celebrating its history and heritage, and inspiring contemplation, reflection, and dialogue;
- 24. and,
- 25. WHEREAS, the President's Public Art Committee has in reality operated in a reactive, rather
- 26. than proactive, manner with art proposals and projects on campus; and,
- 27. WHEREAS, the President's Public Art Committee would benefit from having
- 28. student involvement in its process;
- 29. THEREFORE, be it resolved that the Associated Students of the University of Wyoming
- 30. (ASUW) Student Government recommend that the University of Wyoming (UW) strive to
- 31. find and place art on campus in a proactive, open, and effective manner; and,
- 32. THEREFORE, be it further resolved that the UW, through the President's
- 33. Public Art Committee and the ASUW Student Government, should develop a comprehensive
- 34. Public and Campus Art Plan similar to the City of Laramie Inaugural Public Art Plan; and,
- 35. THEREFORE, be it further resolved by the ASUW Student Government that the President's
- 36. Public Art Committee should include a voting student representative, appointed by the
- 37. ASUW President, in their committee structure; and,
- 38. THEREFORE, be it further resolved that upon passage, a copy of this resolution, along with
- 39. a copy of the city of Laramie Public Art Inaugural Plan, be sent to the UW President, the
- 40. Board of Trustees, and all members of the President's Public Art Committee.
