3. interaction with campus programs and organizations; and,

4. WHEREAS, Student Legal Services (SLS) is a valuable ASUW Program for students at

5. the University of Wyoming (UW) that provides legal advice for students and engages

6. in educational outreach on campus; and,

7. WHEREAS, the ASUW Student Government has declared its commitment to ensuring the

8. long-term success of SLS with the Dean of Students Office through Senate Bill #2465; and,

9. WHEREAS, upon approval of the UW Board of Trustees (BOT), Senate Resolution #0884

10. adopted the Students' Attorney Act which created SLS as an ASUW Program; and,

11. WHEREAS, UW Regulation 8-249 Section II outlines that "the ASUW may establish,

12. modify, and discontinue programs, services, and operations that benefit and promote the

13. general welfare of the students of the University"; and,

14. WHEREAS, the current SLS Mission Statement is focused on offering legal services and

15. does not fully encompass the educational outreach portion of the SLS mission; and,

16. WHEREAS, the current SLS Mission Statement includes clunky and redundant

17. references to ASUW documents that can be referenced in the ASUW Program

18. Description document; and,

- 19. WHEREAS, the SLS program can benefit from a concise, focused Mission Statement to
- 20. guide its daily operations and broader institutional goals.
- 21. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
- 22. (ASUW) Student Government that the revised Student Legal Services (SLS) Mission
- 23. Statement read as outlined in Addendum A.
