




SENATE BILL #2812

TITLE: Creation of an Annual ASUW Strategic Plan Progress Report
DATE INTRODUCED: April 19, 2022
AUTHOR: President Swilling and Director of Governmental and Community Affairs Brown
SPONSORS: Senators Castronovo, Ewalt, Rhymes, and Smith

1. WHEREAS, the purpose of the Associated Students of the University of Wyoming
2. (ASUW) Student Government is to serve our fellow students in the best manner
3. possible; and,
4. WHEREAS, ASUW has consistently maintained a strategic plan, since at least 2001,
5. detailing how our organization ought to move forward and achieve long-standing goals; and,
6. WHEREAS, it is prudent that these be followed up on and adjusted as necessary, so as to
7. maintain the relevance of the strategic plan and to ensure it retains its importance as a
8. guiding document for the long-term development of ASUW; and,
9. WHEREAS, giving the Program and Institutional Committee the task of writing an annual
10. report to the ASUW Strategic Plan, and coming up with adjusts as necessary, would ensure
11. institutional longevity of this document and its goals.
12. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
13. (ASUW) Student Government that the ASUW 2022-2027 Strategic Plan, as shown in
14. Addendum A, be adopted for the period of spring 2022 to spring 2027.

Addendum A

- a. The ASUW Program and Institutional Development Committee
 - i. Purpose: The Program and Institutional Development Committee shall serve as a means by which the ASUW Senate shall advise and assist with all ASUW programs, services and strategic partners. Furthermore, the committee shall be responsible for ensuring that the ASUW is constantly developing into a more effective organization.
 - ii. Powers: The Committee shall advise and assist all ASUW Programs, Services, and Strategic Partners of the ASUW and shall formally and evaluate aspects of the each and provide recommendations ~~which include but are not limited to the budget, student fee allocation, and staffing~~ on how they can best fulfill their mission and goals. The Committee will maintain regular contact with all Programs, Services, and Strategic Partners of the ASUW and will regularly provide institutional and programmatic support to each. The Committee will be responsible for submitting yearly reports to the Budget and Planning Committee pertaining to the effectiveness and need for funding in specific areas for each ASUW program. Additionally, the Committee shall be responsible for the formulation and execution of long term policies and goals for the ASUW Student Government and its Programs, Services, and Strategic Partners. ~~To this end, it shall conduct an annual review of the current ASUW Strategic Plan, with the ASUW President and ASUW Assistant Director also assisting. If necessary, this report shall contain recommended changes to the strategic plan to ensure its continued relevance, which can be passed through the legislative process.~~ PID shall have the authority to request any information it deems necessary of other ASUW Committees and entities, and it shall use this information to determine areas that require additional focus. Subsequently, the Committee will be responsible for formulating action plans to address these areas of concern. The Committee shall be vested with all necessary and appropriate powers to carry out its purpose under these rules.
 - iii. Composition: The Committee shall consist of a minimum of six (6) Senators of the ASUW, one (1) of whom shall serve as chairperson, three (3) ASUW Students-at-Large, one (1) being a First-Year Senator, and a unique student representative of

each ASUW program or service shall have the opportunity to serve as a voting member. All these program and service representatives are subject to the final approval of the ASUW Vice President. All program and service representatives will have the right to vote in this Committee. The ASUW Vice President shall appoint at least one (1) Executive to serve as an ex-officio on the committee. The program and service representatives may be, but are not limited to the following:
