TITLE: Procedure for Selecting First Year Senate Advisor
DATE INTRODUCED: 11/14/23

1. WHEREAS, the purpose of the Associated Students of the University of Wyoming
2. (ASUW) is to serve our fellow students in the best manner possible; and,
3. WHEREAS, the ASUW First-Year Senate (FYS) has an advisor that provides
4. assistance and guidance to the body when needed; and,
5. WHEREAS, when the ASUW Budget allows, the selection of the FYS Advisor
6. sometimes occurs outside of the academic year; and,
7. WHEREAS, the ASUW By-Laws detail the procedure for selecting a FYS Advisor, but
8. the current procedure does not provide instructions for selection during the summer
9. months; and,
10. WHEREAS, when the selection process has previously occurred in the summer, student
11. involvement is limited and difficult; and,
12. WHEREAS, establishing a procedure to select the FYS Advisor that involves ASUW
13. members is essential to the operational integrity of the student government; and,
14. WHEREAS, the following amendment to the ASUW By-Laws would codify procedures
15. to select a FYS Advisor, either during or outside of the academic year; and,
16. WHEREAS, the amendment ensures student involvement in the interview and selection
17. process.

18. THEREFORE, be it enacted by the Associated Students of the University of
19. Wyoming (ASUW) Student Government that the ASUW By-Laws be amended to reflect
20. the changes shown in Addendum A; and,
21. THEREFORE, be it further enacted that these changes take effect on May 3, 2024.

Addendum A

ASUW By-Laws

Article 7. Programs and Services

Section 7.03 Community Programs

10. ~~Section 6 outlines the process by which a student advisor will be chosen to serve the ASUW First-Year Senate. In selecting a student advisor, the Program and Institutional Development Committee will serve as the search committee alongside the ASUW Advisor, appropriate executives, and the outgoing First-Year Senate advisor if attendance is available and appropriate. The ASUW Advisor will serve as chairperson of the search committee.~~ The Program and Institutional Development Committee will serve as the search and selection committee for the ASUW First-Year Senate Advisor alongside the ASUW Advisor, the ASUW Project Coordinator, and the outgoing First-Year Senate Advisor if attendance is available and appropriate. If a First-Year Senate Advisor is to be selected before the beginning of the semester, the Intersession Oversight Committee, the ASUW Advisor, the ASUW Project Coordinator, and the outgoing First-Year Senate Advisor (if available and appropriate) will serve as the search and selection committee. The ASUW Advisor will serve as chairperson of the search and selection committee. The ASUW Advisor, the ASUW Project Coordinator, and at least one student from the committee will conduct candidate interviews.
