1. WHEREAS, the purpose of the Associated Students of the University of Wyoming

- 2. (ASUW) is to serve our fellow students in the best manner possible; and
- 3. WHEREAS, the current ASUW Elections Policy has many discrepancies that need to be
- 4. fixed before the 112th Administration Elections are able to take place in order to allow
- 5. for the most efficient process possible; and,
- 6. WHEREAS, in Section 1.01 subsection 1 Clause B the timeline of when applications
- 7. should open is currently set to be before the fifth week of the second semester; and,
- 8. WHEREAS, due to the other time line requirements within the ASUW Elections Policy
- 9. this sets an awkward amount of time to be left over at the end of the semester; and,
- 10. WHEREAS, the current precedent has been to organize elections in such a way where
- 11. campaigns are allowed to start on the Monday after Spring break which requires
- 12. applications to open between the sixth and seventh weeks of the semester; and,
- 13. WHEREAS, switching this section to state that applications must open up by the end of
- 14. February allows for more adaptation to the year and ensures each administrations
- 15. Homecoming, Outreach, Programming, and Elections Committee can function to the
- 16. best of their ability; and,
- 17. WHEREAS, this change is also rewording the Clause to open applications to all
- 18. University of Wyoming Fee Paying students that qualify under the election requirements,
- 19. rather than just members of ASUW; and,
- 20. WHEREAS, this section of the Election Policy should be changed as reflected in
- 21. Addendum A.

- 22. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
- 23. Student Government that Section 1.01 Subsection 1 Clause B of the ASUW Elections
- 24. Policy be changed as reflected in Addendum A; and
- 25. THEREFORE, be it further resolved that these changes are effective immediately.
