- 1. WHEREAS, the purpose of the Associated Students of the University of Wyoming
- 2. (ASUW) is to serve the students in the best manner possible; and,
- 3. WHEREAS, international students face undue challenges and stress upon their
- 4. arrival due to the lack of transportation from the Denver International Airport (DIA);
- 5. and,
- 6. WHEREAS, faculty, staff, and student volunteers have routinely picked up international
- 7. students from the airport; and,
- 8. WHEREAS, this issue is not unique to International Students given that not all students
- 9. can drive to DIA freely; and,
- 10. WHEREAS, students are obligated to pay large sums of money for alternative
- 11. transportation to Laramie as seen in Addendum A without prior knowledge of the cost;

- 12. and,
- 13. WHEREAS, the University of Wyoming (UW) has the resources to provide
- 14. transportation from the airport to Laramie through charter buses with a 55 people
- 15. and luggage capacity and/or smaller vans with an 8 person and luggage capacity; and,
- 16. WHEREAS, all students will benefit from free transportation to and from DIA; and,
- 17. WHEREAS, a DIA shuttle service has been provided by ASUW to the student body
- 18. Before (Addendum B) with great success as seen in Addendum C, and;
- 19. WHEREAS, international students during a United Multicultural Council (UMC)
- 20. meeting expressed how the absence of this service directly impacts international
- 21. students; and,
- 22. WHEREAS, the International Students Association (ISA) provides a statement of
- 23. support as reflected in Addendum D; and,
- 24. WHEREAS, the Asian and Pacific Islander Student Association (APISA)
- 25. provides a statement of support as reflected in Addendum E; and,
- 26. WHEREAS, the Indian Students' Association (MILAAP) provides a statement of
- 27. support as reflected in Addendum F; and,
- 28. WHEREAS, the Bangladesh Students' Association (BSA) provides a statement of
- 29. support as a reflected in Addendum G; and,
- 30. WHEREAS, Charter Services has quoted \$1362.16 to be the cost of one round trip for a
- 31. charter bus that seats a maximum of 55 people; and,
- 32. THEREFORE, be it enacted ASUW pledges to spend money to provide this service
- 33. annually unless another campus entity subsidizes the cost in the future; and,
- 34. THEREFORE, be it further enacted that there will be at minimum two University of
- 35. Wyoming (UW) fleet vehicles, prior to the Fall semester one two weeks before the
- 36. beginning of the Fall Semester coinciding with International Student Orientation, and
- 37. one week before the beginning of the fall semester coinciding with Saddle Up Moving
- 38. day, two at the end of the Fall semester, two prior to the start of the Spring semester and
- 39. two at the end of the Spring semester from Denver International Airport to the UW; and,
- 40. THEREFORE, be it enacted that \$10,897.28 from the ASUW carry-over account be
- 41. allocated for a new line item titled "ASUW DIA Transportation Shuttle Services"
- 42. in the FY25 ASUW budget; and,

- 43. THEREFORE, be it further enacted that the ASUW executive branch in conjunction
- 44. with the ASUW professional staff will administer reservations, unless another campus
- 45. entity is more appropriate and willing to handle such reservations as determined by the
- 46. Vice President of Student Affairs Kim Chestnut; and,
- 47. THEREFORE, be it further enacted that this legislation be sent to the UW Transit
- 48. Department and International Student Services, Director of International Student
- 49. Services Jill Johnson, and Vice President of Student Affairs Kim Chestnut.




Figure 1 Laramie Regional Airport to DIA flight prices




Figure 2 Shorelight Email Communication

AIRPORT TRANSPORTATION

Although Transportation Services does not provide general transportation to/from the Laramie Regional Airport or the Denver International Airport , there are several resources available. List of alternative transportation resources around the Laramie area.

University of Wyoming International students may qualify for airport transportation from the Laramie Regional Airport before the start of the semester. See below for details.

International Student Airport Shuttle

The closest international airport to Laramie, Wyoming is Denver International Airport (DEN) in Denver, Colorado. You should fly first to Denver International Airport (DEN) and then make your way to Laramie.

From Denver International Airport (DEN), there are two ways to get to Laramie that we recommend:

1. You can fly directly in to the Laramie Regional Airport. The airportoffers United Express/SkyWest Airlines flights to Laramie from Denver daily. If you need shuttle service from Laramie Regional Airport into town, please email Transportation Services (tps@uwyo.edu) with your request no less than 14 days before your arrival. This service costs \$15 which will be added to your student bill. If your plans change or you make other arrangements for transportation, please let Transportationfd Services know as soon as possible. Otherwise, you will still be billed the \$15 charge regardless of whether you used the service or not.

2. Groome Transportation DIA Airport Shuttle also provides regular shuttle service from the Denver International Airport to Laramie. Rates are around \$80. Groome Transportation can deliver you right to campus.

Regardless of how you get to Laramie, please let ISS know your travel arrangement as soon as possible if you haven't already done so. We must know when our new students are expected to arrive. You can email this information to International Students and Scholars

WHEREAS, various University departments and students have recognized

18, 2004 and on January 7, 8, and 9, 2005 to coincide with the start and end of

WHEREAS, the UW infrastructure includes such resources as vehicles and

insurance which make providing this transportation service feasible; and

WHEREAS, financial support from University departments and the

11. Associated Students of the University of Wyoming is needed to provide the

service to students at an affordable cost.

14. Wyoming that \$3,000 be allocated from the ASUW reserve account to

IV. ASUW Programs

Safe-Ride

Safe Ride has been operational since the 2000-2001 academic year. Its ridership has increased in each subsequent year to over 20,000 riders in academic year 2003-2004, and projected ridership in academic year 2004-2005 of ~26,000. Increased ridership has led to increased problems in managing the program including funding, safety, and efficiency.

Recommendations:

ASUW should implement the Safe Ride Strategic Plan of 2005. Additionally, ASUW should seek to turn over operations of the fixed-route van system to Auxiliary Services, the City of Laramie, or another vendor who would maintain a comparable service. Outside funding sources should be sought for the on-call system from the city, local businesses, and state, federal, and private grant dollars.

Areas of Collaboration:

ASUW should seek consultation from individuals in Fleet Operations and TransPark for the day to day operations of the program. Some collaboration may be possible with local businesses and the city for advertising and funding. Enterprise, or a similar business should be considered for vehicle partnership.

DIA Transportation

The lack of affordable transportation to DIA was viewed by ASUW as concern among students. In response, ASUW conducted a pilot DIA shuttle over the FY05 winter break. Round trip and one-way tickets were offered at a subsidized rate with the help of many campus donors. 155 of the 162 available seats were sold, and the feedback from the campus community has been very positive. The service was offered again over the 2005 spring break with 87 of the 90 available seats being sold.

Recommendations:

Because of the program's success and continued demand, establishing regular service to DIA at peak times during the year for UW students should be an annual priority for ASUW leadership. Key elements of the service should include subsidized ticket prices to students, service operation during Winter Break, and Thanksgiving Break, with the potential option of increasing the service to include Spring Break, the beginning and end of the academic year, and Summer Orientation sessions. Ultimately, it should be the goal of ASUW to assist another University entity or outside vendor in permanently developing the service.

Areas of Collaboration

Any area of the University or Laramie community interested in permanently offering the service or assisting in funding the service should be considered, including but not limited to the Laramie Regional Airport, Enterprise Rent-a-Car, and TransPark. Use of campus resources such as University of Wyoming Risk Management and Auxiliary Services will also be necessary for continuing this program.
