1. WHEREAS, the purpose of the Associated Students of the University of Wyoming

2. (ASUW) is to serve our fellow students in the best manner possible; and,

- 3. WHEREAS, with the newly created ASUW DIA Shuttle Service there is a need for a
- 4. committee that will help manage tasks related to the Shuttle Service during the
- 5. Academic Year; and,
- 6. WHEREAS, these tasks include, but are not limited to, reviewing applications, selecting
- 7. shuttle pick up and drop off times, and managing waitlists; and,
- 8. WHEREAS; this committee would also allow for the execution and continuation of the
- 9. ASUW DIA Shuttle Service past the ASUW 111th Administration; and,
- 10. WHEREAS, this committee would operate on a need basis or infrequent basis similar to
- 11. the Tuition, Allocations, and Student Fee Review Committee of the committee; and,
- 12. WHEREAS, this committee shall seek alternative campus entities to take on the
- 13. responsibility of running the DIA Shuttle Service as ASUW is not a transportation
- 14. expert nor should it have to expend its resources to become one; and,
- 15. WHEREAS, this committee will only operate when ASUW Senate is operating.



- 16. THEREFORE, be it enacted that a special committee deemed the "DIA Shuttle Service
- 17. Committee" be established at the beginning of the 112th ASUW administration to
- 18. operate until the end of ASUW DIA Shuttle Service after which it shall either be
- 19. dissolved through a subsequent piece of legislation; and,
- 20. THEREFORE, be it further enacted that upon passage of this legislation the bylaws be
- 21. appropriately renumbered to preserve the structure of the bylaws while creating these
- 22. changes; and,
- 23. THEREFORE, be it further enacted that the powers and composition of this committee
- 24. are outlined in the ASUW Bylaw changes seen in Addendum A and,
- 25. THEREFORE, be it further enacted that these changes go into effect at the beginning of
- 26. the ASUW 112th administration; and,
- 27. THEREFORE, be it further enacted that this committee shall operate until a time when
- 28. another campus entity can take on the DIA Shuttle Service, after which the committee
- 29. shall cease to operate.

## Addendum A

## 12. Special Committees

## F. The ASUW DIA Shuttle Service Committee:

- a. Purpose: The Committee shall serve as a means by which the ASUW shall seek to review student applications for the ASUW DIA Shuttle Service. The Committee shall select 55 or less student applicants that will receive the service. As well as a waitlist, if more than 55 students applied to the service. The Committee shall have the responsibility to contact UW Transportation Services to coordinate the acquirement of transportation shuttles to be used for the DIA Shuttle Service. The committee will seek other campus entities that are better equipped to take on the responsibility of the DIA Shuttle Service.
- b. <u>Powers:</u> The powers of this committee shall act in accordance to the DIA Shuttle Service Policy, University Regulations, the ASUW bylaws, rules and procedures and other relevant working documents and shall be limited to the contents of those policies and regulations. The Committee's powers shall include, but are not limited to, the ability to select, waitlist, and deny applicants, meet with university administrators, officials, and personnel, draft legislation and make appropriate recommendations to the ASUW Senate the DIA Shuttle Service Policy, and handle student policy infractions.
- c. <u>Composition:</u> The ASUW DIA Shuttle Service Special Committee shall be composed of six (6) ASUW Senators, and two (2) Students-at-Large appointed by the ASUW Vice President. The ASUW Vice President shall appoint an ASUW executive to serve as chairperson of the committee. The ASUW Vice President may appoint ASUW executives to serve as exofficion on the committee.
