Addendum B

ASUW Specific Actions for Each Fee

Mandatory Fees

- The ASUW Student Fee Review Committee voted to maintain the Intercollegiate Athletics student fee at its current value with a 4% requested increase due to a consensus among the committee that Intercollegiate had sufficient funding.
- The ASUW Student Fee Review Committee voted to maintain the Distance Advising student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Distant Student Services student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Music and Theatre student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to increase the Transit student fee by 8.7% due to increased vehicle parts and fuel costs and to make two routes go later into the evening.
- The ASUW Student Fee Review Committee voted to decrease the Student Media student fee by 15% to \$18 due to inefficient usage of ad space, lack of initiative regarding the broadcasting project, concerns regarding funding usage efficacy, sustainability concerns regarding paper usage, reserve overflow, and general readership.
- The ASUW Student Fee Review Committee voted to decrease the ASUW student fee by -22.73% to \$42.50 due to having more funds than needed and Student Technical Services being transferred to the Wyoming Union. The Student Technical Services fee was \$7.91 that was subtracted from ASUW's FY24 fee of \$55. The rest of the decrease was recommended in committee.
- The ASUW Student Fee Review Committee voted to maintain the Distance Delivery Fee at its current values with a 68% increase requested. The committee's rationale was that the reasons given to increase the fee would not make our online programs competitive with other schools despite the requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Consolidated Student Services fee at its current value (excluding the expected increase due to the addition of Student Technical Services) despite the anticipated 4% increase due to seeing that Consolidated Student Services has plenty of funding and a large reserves account.
- The ASUW Student Fee Review Committee voted to maintain the Recycling student fee at its current value due to this department not scheduling a hearing with the committee. They evidently do not need an increase.
- The ASUW Student Fee Review Committee voted to maintain the Student Success student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Advising Fee at its current value despite- a requested 25% increase due to concerns regarding quality of advising campus wide according to ASUW's constituents.

- The ASUW Student Fee Review Committee voted to maintain the 2nd Chance Pell Program Fee at its current value due to this party not scheduling a hearing with the committee. They evidently do not need an increase.
- The ASUW Student Fee Review Committee voted to decrease the Onboarding Fee by 25% with a requested decrease of 25%. The committee strongly believes that unless public opinion changes about the performance of the Saddle Up program then further cuts will be required.
- The ASUW Student Fee Review Committee voted to maintain the Degree Completion student fee at its current value with no requested increase.

Program Fees

- The ASUW Student Fee Review Committee voted to maintain the A&S Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the A&S Sci-Q Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the A&S VPA Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Health Sciences Program student fee at its current values with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Health Sciences Communication Disorder Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Health Sciences Kinesiology and Health Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Nursing Program student fee at its current value with no increase requested.
- The ASUW Student Fee Review Committee voted to increase the Social Work student fee by 10%. The program is bought from an outside source who increased their price.
- The ASUW Student Fee Review Committee voted to maintain the Engineering Program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Engineering Sci-Q student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Agriculture Sci-Q program student fee at its current value with no requested increase.
- The ASUW Student Fee Review Committee voted to maintain the Business program student fee at its current value due to this party not scheduling a hearing with the committee. They evidently do not need an increase.
- The ASUW Student Fee Review Committee voted to maintain the Education program student fee at its current value due to this party not scheduling a hearing with the committee. They evidently do not need an increase.
- The ASUW Student Fee Review Committee voted to maintain the Haub School program student fee at its current value due to this party not scheduling a hearing with the committee. They evidently do not need an increase.

- The ASUW Student Fee Review Committee voted to maintain the Honors program student fee at its current value due to this party not scheduling a hearing with the committee. They evidently do not need an increase.
- The ASUW Student Fee Review Committee voted to increase the WYDENT fees by 4% with a requested increase of 4% to keep up with tuition costs.
- The ASUW Student Fee Review Committee voted to increase the WWAMI fees by 4% with a requested 4% increase to keep up with tuition costs.
- The ASUW Student Fee Review Committee voted to increase the Family Nurse Practitioner fee by 4% with a requested increase of 4% due to additional required course work.
- The ASUW Student Fee Review Committee voted to approve the Undergraduate Basic Software fee at its requested rate.

Business Enterprise Fees

- The ASUW Student Fee Review Committee voted to maintain all Housing fees. This party did not schedule a hearing with the committee, therefore not holding itself accountable to the elected representatives of the student body rendering them not -entitled to any increases.
- The ASUW Student Fee Review Committee voted to maintain all Dining fees. This party did not schedule a hearing with the committee, therefore not holding itself accountable to the elected representatives of the student body rendering them not entitled to any increases.
- The ASUW Student Fee Review Committee voted to decrease Parking Permit fees by 10% and maintain all other fees. This party did not schedule a hearing with the committee, therefore not holding itself accountable to the elected representatives of the student body rendering them not entitled to any increases.
- The ASUW Student Fee Review Committee voted to maintain all Field Course fees. This party did not request a hearing with the committee.

Other Fees

- The ASUW Student Fee Review Committee voted to maintain the International Student Study Abroad student fee at its current value with no request for increase.
- The ASUW Student Fee Review Committee voted to maintain the WyGISC student fee at its current value with no requested increase.
