1. WHEREAS, it is the purpose of the Associated Students of the University of Wyoming

- 2. (ASUW) Student Government to serve our fellow students in the best manner possible
- 3. through accurate representation; and,
- 4. WHEREAS, safety is a growing concern on college campuses, and has been at the
- 5. the forefront of campus improvement conversations at the University of Wyoming; and,
- WHEREAS, the ASUW Student Government, as the recognized student voice at the
- 7. University of Wyoming (UW), should actively look for ways to improve student sense of
- 8. safety and UW President Nichols has been vocal about support for safety improvements; and,
- 9. WHEREAS, at the UW in the 2017 calendar year there were 31 deployments to Blue Light
- 10. Emergency Phones, exactly 1,100 criminal law criminal cases, and 3,154
- 11. non-criminal cases including medical calls and emergencies where the officers did not write
- 12. a report; and,
- 13. WHEREAS, colleges and universities across the United States are moving towards
- 14. mobile application-based safety and emergency reporting software; and,
- 15. WHEREAS, Rave Guardian is a two-way critical communications and personal safety app
- 16. and describes their services as "Extend(ing) your safety umbrella to people worldwide using

- 17. mobile phone technology. Rave Guardian offers 24/7 two-way connectivity between security
- 18. resources and people exposed to risk wherever they are;" and,
- 19. WHEREAS, Rave Guardian has many benefits over other options including, customization,
- 20. real-time reporting and communication for law enforcement, in app anonymous tip
- 21. solutions, user safety timers, and non-student guardian options; and,
- 22. WHEREAS, the University of Wyoming already has a contract with Rave for the UW
- 23. Emergency Alert System allowing for an addition to the current contract in order to
- 24. implement Rave Guardian, drastically reducing both time and cost of bringing the software
- 25. to campus; and,
- 26. WHEREAS, the ASUW Student Government requested cost estimates from Rave Mobile
- 27. Safety in 2015 and the cost was approximately \$30,000 a year; and,
- 28. WHEREAS, the contract addendum received from Rave Guardian outlined in addendum A
- 29. entails a \$2,000 one-time implementation fee and a \$6,000 yearly fee making Rave Guardian
- 30. an economically sound choice; and,
- 31. WHEREAS, the ASUW Student Government has a surplus of funding in the Fiscal Year
- 32. 2018 Operating Budget of \$50,480.
- 33. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
- 34. (ASUW) Student Government that \$4,800 be realigned from the Salaries Line Item in the
- 35. ASUW Business Office Budget to Special Contract Services in the ASUW Executive
- 36. Branch, as outlined in Addendum B, to fund Rave Guardian for the remainder of the FY18;
- 37. and,
- 38. THEREFORE, be it further enacted that \$12,000, \$6,000 per Fiscal Year be allocated from
- 39. the ASUW Reserve to support the Rave Guardian Contract for FY19, and FY20 fiscal years

- 40. in order to assess its effectiveness at the University of Wyoming; and,
- 41. THEREFORE, be it further enacted that the ASUW Executive Branch enact a live
- 42. demonstration or education time during the Summer Freshman Orientation and two
- 43. education sessions in the Fall of 2018 for all returning students to campus.
