1. WHEREAS, the Mission of the Associated Students of the University of Wyoming

2. (ASUW) is "to serve its students in the best manner possible through accurate

- 3. representation, professional interaction with campus programs and organizations, and
- 4. responsible, effective, leadership;" and,
- 5. WHEREAS, the ASUW Freshman Senate passed Freshman Senate Bill #53 to change
- 6. their name to First-Year Senate; and,
- 7. WHEREAS, this change will allow Freshman Senate to be more inclusive of first-year
- 8. nontraditional students, veterans, gender nonconforming students, and other first-year
- 9. students you do not identify with the term "freshman;" and,
- 10. WHEREAS, Freshman Senate Bill #53 requested that the ASUW Student Government
- 11. make the appropriate changes to all relevant working documents to reflect this name
- 12. change; and;
- 13. WHEREAS, this requires a constitutional amendment.
- 14. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
- 15. (ASUW) Student government that the ASUW Constitution be amended to reflect the

- 16. changes in Addendum A; and,
- 17. THEREFORE, be it enacted that Senate Bill #2613 be included in the 2018 General
- 18. Election ballot as a referendum using the question in Addendum B; and,
- 19. THEREFORE, be it further enacted that this bill will go into effect upon passage by the
- 20. University of Wyoming Board of Trustees.

Addendum A

ARTICLE IV

Appointed or Elected Officers

Section 4.	An Ex-Officio member is a representative chosen by an entity, and with
	the exception of the ASUW First-Year Senate Ex-Officio who shall enjoy
	all rights of senate membership except the right to vote.

Section 5. The ASUW <u>First-Year Senate</u> Ex-Officio shall enjoy all rights of senate membership including the right to vote.

ARTICLE VI

ASUW Legislative Branch

The Legislative Branch of the ASUW shall consist of the ASUW Vice President, a student senate, which shall be made up of the student senators annually elected by the ASUW membership, and <u>First-Year Senate</u> Ex-Officio. All legislative powers of the ASUW shall be vested in the ASUW Student Senate.

ARTICLE VIII

Meetings and Quorum

Section 1.

The business of the ASUW Senate shall be conducted in accordance with procedures set forth in the ASUW By-Laws and which shall include the following:

- A. Regular ASUW Senate meetings shall be held each week during Fall and Spring semester except for University vacations and holidays or by a two-thirds (2/3) vote of the Senate;
- B. Regular ASUW Senate meetings shall be relocated as determined by the ASUW Senate a minimum of once per semester.
- C. Special meetings of the ASUW may be called by the Chairperson of the ASUW Senate, the ASUW Vice President, or upon written demand of one-third (1/3) of the current ASUW Senate membership;
- D. In order to conduct official business of the ASUW Senate, a quorum of two-thirds (2/3) of the voting membership of the Senate shall be present; and

E. Each ASUW Senator, and First Year Senate Ex-Officio, shall be entitled to one (1) vote on any issue before the Senate, and voting by proxy shall not be allowed.
