- 1. WHEREAS, the purpose of the Associated Students of the University of
- 2. Wyoming (ASUW) is to serve our fellow students in the best manner possible; and,
- 3. WHEREAS, the current biweekly communication reports during ASUW Senate
- 4. Meetings do not include committees; and,
- 5. WHEREAS, committee reports existed in the ASUW By-Laws and communications
- 6. in previous administrations, but were removed due to the long meetings that had
- 7. both special events and communications; and,
- 8. WHEREAS, as seen in Addendum B, Senate Bill #2853 changed communications and
- 9. special events to inversely be biweekly, reducing this previous concern; and,
- 10. WHEREAS, committee reports are valuable sources of information to ensure the body
- 11. is aware of all projects, reducing the likelihood of senators doubling up on projects; and,
- 12. WHEREAS, the College Council neither attends ASUW Committee meetings nor exists.
- 13. THEREFORE, be it enacted that the ASUW Student Government amend Article 2
- 14. Section 2.01 of the ASUW By-Laws to reflect the changes outlined in Addendum A;

1. WHEREAS, the purpose of the Associated Students of the University of Wyoming		
2. (ASUW) is to serve our fellow students in the best manner possible; and,		
3. WHEREAS, ASUW Senate meetings are often very long, and reducing their length would		
4. save student fee dollars; and,		
5. WHEREAS, ASUW Senate meetings can be reformed to maximize their efficiency; and,		
6. WHEREAS, holding special events and communications only every other week, and		
7. alternating between them so that they do not occur on the same week, will save significant		
8. time; and,		
9. WHEREAS, to prevent s	significant potential drawbacks of this change, the ASUW Steering	
10. Committee could decide to hold a special event anyway, but only if they deem it crucial;		
11. and,		
12. WHEREAS, switching the order of old and new business with communications will help		
13. ensure that the most important aspects of the meetings, such as voting on legislation, take		
14. place earlier in the meeting; and,		
15. WHEREAS, eliminating committee and executive verbal communications, except for the		
16. President and Vice President shall also help to speed up meetings.		
17. THEREFORE, be it enacted that the ASUW Rules and Procedures be amended to reflect		

18. the changes outlined in Addendum A; and,

19. THEREFORE, be it further enacted that these changes shall take effect immediately upon

20. passage of this bill.
