<u>OPEN FORUM</u>

SAL Artemis Langford expressed discontent with SF#117 and argued that there is little regard for LGBTQ+ students' lives. Subsequently, that this state legislation could lead to further harm in the community, which could kill students in the state. SAL Langford expresses that three students have lost their life because of cruel treatment to them.

VP Kim Chestnut spoke about President Brown's consideration to remove ASUW through Student Affairs. Kim Chestnut wanted to provide an idea to create a special committee to modify.

The President of the Bangladesh Students Association spoke on behalf of the SOFB event request for the Bangladesh night.

issues. He talked about lobbying and what it is. He took examples from members who have lobbied before. He talked about running elections and shaping the press to get your narrative out there. He discussed how a bill becomes a law in the state of Wyoming.

COMMUNICATIONS

Executive Reports

President Brown: "Congratulation to our new senators! I welcome you all to ASUW and so look forward to working with you all! My office downstairs is always open! I will try to keep it brief, as I know the majority of communications have been limited to 5 minutes and as we have an incredibly busy agenda tonight – and it is already late. Congratulations to our friends from IFC/CPH and in FSL, so excited to hear that you all will be going to testify on that bill and are seeing the results of your work on this issue! Director Heddins will be attending with you all, with a p-card, so please do let her/us know what all we can do to help. Additionally, when I send out our student newsletter tomorrow as planned, I will be asking in our planned section about student advocacy for students to reach out to relevant lawmakers on this issue. Thanks to Nate Morneau for that event. I just wanted to clarify statements I've made prior that ASUW students are more than welcome to go and advocate to the state legislature, but I ask that we wait to say

we represent ASUW until legislation has been passed by the senate, showing our opinion, as we want to ensure we have formed our opinion on behalf of all students. Thank you, VP Chestnut, for sharing those remarks about the initial conversations I enjoyed with the Chairman of the Board of Trustees last week and providing that initial insight, I wasn't certain that the news was able to be shared that I met with the Chairman so thank you for that. I certainly think that an adhoc committee is an idea which we could further examine. Last week, I had an initial conversation with Chairman McKinley, administration, and Staff Senate Leadership about exploring the potential for ASUW, and Staff Senate, to shift our budget reporting line from the Division of Student Affairs to the Division of Financial Affairs while maintaining our line of reporting authority to the Division of Student Affairs. This conversation was an initial discussion regarding shifting these lines and what it could look like for ASUW to potentially shift our budget reporting line. All things considered, when I receive a draft of what the ASUW Regulation, 11-5, looks like I will communicate that all with you and go through the proper channels of approving that by this body. Senate insights and of course approval is essential in this process. So certainty more to come in the next few weeks, I welcome any and all questions on this initial conversation. AA&SA, Biennium Budget Committees had the vote on the 15% increase for dining and housing, I spoke against it in committee. I have updated the draft of the strategic plan, which I can share with you all or you can search online Tuition Policy changes were voted down! Thanks to my collaboration with Faculty Senate and Trustee True. Introductions to new VPs: VP Hall, VP for Online, Continuing Education Matt Griswold which shared his interests in working with us/being a special event here. There are three primary concerns for campus this spring: parking/transportation, freedom of expression/community inclusion on campus, and affordability of UW Freedom of Expression Working Committee broke into subcommittees: Institutional Mapping and Operationalization and Implementation. The Block Tuition Exemption Committee will have a continued discussion regarding Exemption Applications and/or a bank of hours if students don't use all. We are looking for grad/younger undergraduates to fill external committees. Budget Realignment to be a cosponsors on a distinguished lecturer coming this spring for \$1,000 from unspent exec/senate salaries. Budget Hearing for Executive Branch – again welcome any/all questions the Student Issues Survey will be the week of February 13-17 I will go on a committee tour with the questions – I will be reaching out to committee chairs to schedule Seidel's Cabinet on Thursday. The ChatGBT and AI Working Group Friday New Ad-Hoc meetings for wages/student employment and accessibility Meeting with VP Swilling, Chief of Staff Skorcz, and Accountant Schaef and Office Associate Lobato to talk about adding tech updates, like microphones and other updates to better tech and accessibility."

Chief of Staff Skorcz reported on behalf of Director Macey who has been working diligently on his Campus Heartbeat application and works with the HAUB school and other relevant stakeholders to discuss sustainability on campus and handed out tabling for sustainability initiatives. This tabling will welcome students to a Hydrogen energy event for Wednesday. He is working with the School of Computing to invite leadership of the CEO of Adaptive where ASUW members can view in the Warm Valley Room at 11:00 a.m. VP Hall is having a meet and greet from 11:00-12:30 on Thursday. Ad-hoc accessibility will be meeting this Friday.

Chief of Legislative Affairs Smith will be scheduling senator check-ins.

Director of Diversity, Equity, and Inclusion Sapien not present.

Director of Student Outreach Murfitt was not present.

Director of Student Organizations Acosta-Engavo not present.

Director of Finance Hamilton had no report.

Director of Governmental and Community Affairs Heddins has been working with the City Council to give out more local parking permits.
