# **ASUW SENATE MEETING MINUTES**

The November 8<sup>th</sup>, 2022, senate meeting was called to order by Vice President Swilling at 7:03 p.m. The land acknowledgement statement and mission statement were read, and the Pledge of Allegiance was done at the individual members' discretion.

## **ROLL CALL**

No Senators were absent.

## APPROVAL OF MINUTES

# APPROVAL OF AGENDA

Senator Sapien moved to adopt the amendments to the agenda outlined by Vice-President Swilling.

# SPECIAL EVENT UNIVERSITY OF WYOMING

Taylor Stuemky the Associate Athletic Director for Internal Operations, spoke on behalf of the Student Athlete Advisory Committee. She has worked extensively at the University of Wyoming (UW) in many capacities regarding athletics. She is a liaison for the Title IX office and works with Dean of Students Ryan O'Neil. Stuemky reported on the 2018 Campus Climate Survey, which revealed alarming rates of sexual assault at UW. UW Athletics responded to these results by helping find a full-time position (Director of Student-Athlete Well-Being) who is able to provide individual therapy/counseling and also be a resource for survivors of sexual assault and other impacted parties. Stuemky spoke about a TNG Proposal which would bring Title IX consulting to UW for an extended program (4 years) to teach our student-athletes about various topics that are specific to their age group/year in school. Jim Osborn the Title IX Coordinator at the University of Wyoming recommended W. Scott Lewis, J.D. The TNG pricing is around \$90,000. Stuemky asked the Senate for funding assistance for the TNG proposal.
