OLD BUSINESS

SB 3066 Limiting Inflation of Sponsorship Lists

Steering and PID recommended a do pass.

Senator Kaiser moved to pass SB 3066. Senator Moore seconded.

By a vote of 20-0-0, the legislation passes.

SR 3067 A Resolution Encouraging the Wyoming State Legislature to Expand the Hathaway Scholarship Program

Steering and TASFRC recommended a do pass. SWAC and Hathaway Ad-Hoc recommended a do pass with amendments

Senator Morales moved to pass SR 3067, Senator Keasling seconded.

Senator Morales proposed the Hathaway Ad-Hoc amendment, Senator Keasling seconded.

Senator Smith moved to amend the amendment, Senator Kaiser seconded. The amendment and second were rescinded.

The Hathaway amendments were passed by a standing vote of 20-0-0.

Senator Smith moved for unanimous consent, seconded by Senator Keasling. The legislation was passed by unanimous consent.

NEW BUSINESS

SR 3068 Student Fee Recommendation for FY27 was read for the first time. This legislation was steered to TASFRC, B&P, and SWAC
