The PCCR spoke to the Senate about resources available to students.

OLD BUSINESS

SR 3069 ASUW Supports Expanding Availability and Accessibility of Student Parking at the University of Wyoming

SWAC and TASFRC Recommended a do pass.

Senator Robinson moved to pass; Senator Swingley seconded.

Senator Kaiser moved to pass with unanimous consent; Senator Robinson seconded.

SR 3069 was passed with unanimous consent.

SB 3070 Revision to the Non-Traditional Student Council Constitution to be Reflective of the ASUW By-Laws

PID recommended a do pass with amendments. Steering recommended a do pass.

Senator Robinson moved to pass the PID amendment; Senator Swingley seconded.

Senator Smith moved to object to the decision of the chair to amend and pass legislation in the same vote; Senator Swingley seconded. The decision was sustained.

By a vote of 18-2-0, SB 3070 passes.

SR 3071 ASUW Supports the Creation of a Global Environmental Futures Graduate Certificate

SWAC and TASFRC recommended a do pass.

Senator Kaiser moved to pass; FYS Martinez.

By a vote of 18-2-0, SR 3071 passes.

SR 3072 Support for the Creation of a Doctorate in Health Sciences

SWAC and TASFRC recommended a do pass.

Senator Kaiser moved to pass; Senator Smith seconded.

By a vote of 20-0-0, SR 3072 passes.

SB 3073 ASUW Special Projects Approval FY26

B&P, HOPE, SWAC, and TASFRC recommended a do pass

Senator Robinson moved to pass; Senator Hansen seconded.

By a vote of 20-0-0, SB 3073 passes.

SB 3074 Authorizing Expenditures from the ASUW Designated Operating Budget for Special Projects

Steering, B&P, TASFRC, HOPE recommended a do pass. SWAC recommended a do pass with amendments.

Senator Smith moved to pass, seconded by FYS Martinez.

Senator Swingley moved to adopt SWAC's amendments, seconded by Senator Smith.

By a majority vote, the amendment fails.

By a vote of 19-1-0, SB 3074 passes.

NEW BUSINESS

SB 3075 Changing Resolution Sponsorship Requirements to Require Recognized Student Organization Support was read for the first time. This legislation was steered to Steering, SOFB, and PID.

SR 3076 A Resolution Advocating for Increasing Parking South of the North and South Dormitories was read for the first time. This legislation was steered to SWAC and HOPE.

SR 3077 Support for an Increase in the Graduate Assistantship Stipend was read for the first time. This legislation was steered to SWAC.

SB 3078 Rewriting the Student Organization Funding Board Policy in Accordance with the University Audit was read for the first time. This legislation was steered to SOFB and PID.

SB 3079 Adding Event Attendance Requirements for SOFB Members to the ASUW By-Laws was read for the first time. This legislation was steered to SOFB and PID.

SB 3080 Rewriting the Budget and Planning Finance Policy in Accordance with the University Audit was read for the first time. This legislation was steered to B&P and PID.
