Student Fees is based on (Fall/Spring): \$45.69/semester X 9,106 students X 2 semesters =\$832106.28

Summer Student Fees: \$4.40/credit hr. X 9,500 credits = \$41,800

This is subject to change based on actual enrollment numbers

Fees: Every full-time student pays \$45.69 to ASUW as part of their mandatory fees that are paid with tuition.

Summer Fees: Every student who takes summer classes is charged with an additional \$4.40 per credit hour (not to exceed \$43.19 per student) that goes to ASUW

Reserves: The purpose of maintaining modest unrestricted operating reserves at the ASUW is to ensure the financial health and stability of ASUW, and to provide an additional measurement of the fiscal condition of ASUW. Generally, there are three primary uses for reserves:

- a. To provide support in the event of a sudden shortfall in revenue (e.g., unforeseen drop in enrollment or a reduction in state appropriation)
- b. To cover unanticipated expenditures (e.g., unanticipated increases in utility costs, deferred maintenance item that requires immediate attention, legal fees, faculty start-ups, etc.)
- c. To fund unexpected opportunities and provide for extraordinary, one-time investments.

Endowment: An endowment is money that is set aside with specific objectives to be invested by the University of Wyoming foundation. ASUW oversees several endowments with multiple purposes, including student scholarships, facilities improvements, campus projects and financial wellness.

Total Allocated Amount: This is money that is approved and allocated by the ASUW senate for each department, program, and services. This is a total of Student Fees, Summer Fees, Reserves and Endowments.

EXECUTIVE BRANCH



The ASUW Executive Branch is composed of the ASUW President and Vice President, as well as student executive positions that vary in order to accomplish the respective goals of each administration. The executives are appointed by the President with consent of the ASUW Senate, via an application process at the start of each presidential term at the end of the Spring semester.

LEGISLATIVE BRANCH



The ASUW Senate is composed of elected students from each of the colleges at the University of Wyoming, chaired by the Vice President. It is the role of the Senate to conduct legislative action and connect with officials on campus. The ASUW Legislative Branch directly represents the students by ensuring the efficient, responsible, and coordinated functioning of student life and ASUW activities at the University, through the enactment of legislation in the form of bills or resolutions. The Senate is comprised of multiple committees all with various purposes in order to accurately represent our fellow students. ASUW Senators have the opportunity to effect change on campus and in our student community, and it is their responsibility to represent their respective colleges in the decision making of the Student Government. Senator elections take place every Spring semester, or in case of a vacancy.

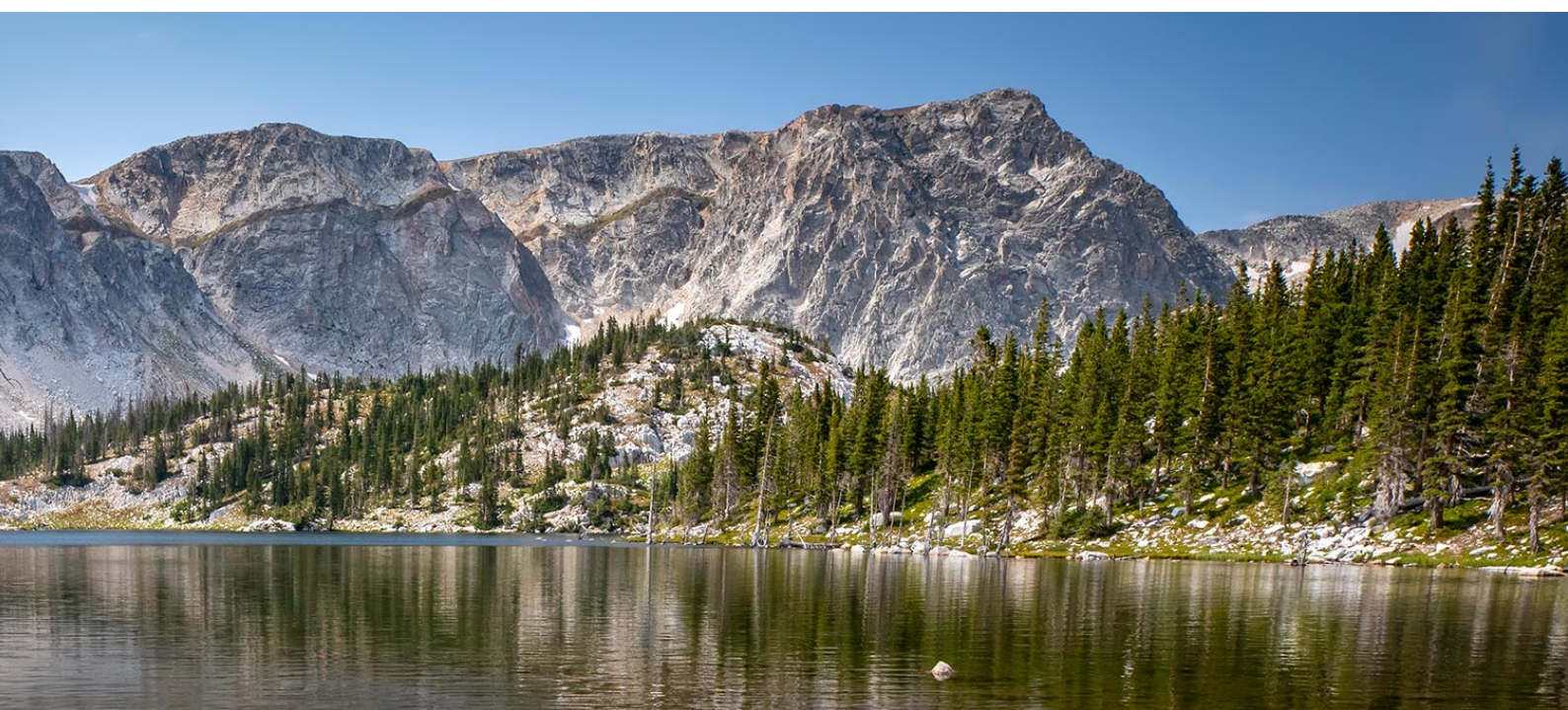
SUSTAINABILITY COALITION

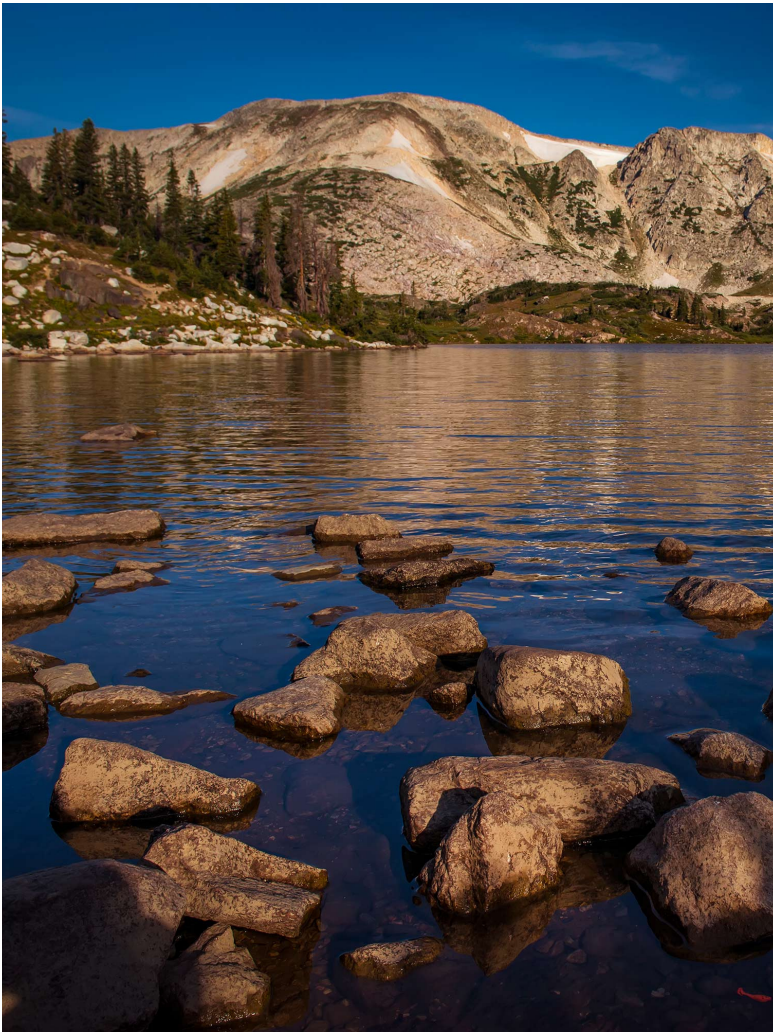
ASTEC
