The instructor is not on campus this semester. Virtual office hours are Wednesday and Thursday from 3:00 to 4:30 pm. However, feel free to contact the instructor at any time. Communication by email or phone is welcomed and encouraged. The goal is to make this class a learning experience for students and the instructor, and an on-going dialogue between students and the instructor is seen as an important component of learning. The instructor typically spends several hours each day working on the computer. An email may be answered within minutes, and will generally be answered the same day. It will be a rare occasion that an email is not returned within 24 hours. The phone number listed above is a cell phone; voice mail is available and you may text to that number as well.

Course Description

Prerequisites, Co-requisites, and Enrollment Restrictions: The following are prerequisites for this course: CRMJ 1001 – Introduction to Criminal Justice, CRMJ 2210 – Criminal Law, and CRMJ/SOC 2400 - Criminology. Students must have junior standing to enroll in this course.

Course Description: Compares the incidence, trends, control, treatment and prevention of crime across nations using mainstream criminological theories. Examines criminal justice systems from an international perspective and draws lessons for the American society. Explores forms of international cooperation and difficulties in the control of transnational crimes.

Student Learning Outcomes: At the end of the course, students will be able to:

- > Describe the basic crime patterns in different regions or countries around the world
- Identify social, economic, political, and cultural factors that relate to criminal justice policies and practices in different countries

- > Discuss the various typologies used to compare criminal justice systems
- Describe the relationships between governments and their citizens in relation to crime and societal responses to that crime

Required Texts, Readings, and Special Tools or Materials: This course will use one primary textbook and one supplemental textbook. Resource articles and background material for the simulation will also be utilized; these will be posted on WyoCourses. The following are required:

- Primary textbook Comparative Criminal Justice Systems, 5th Edition, by Harry R. Dammer and Jay S. Albanese.
- Secondary Textbook Publication Manual of the American Psychological Association (6th ed.), by APA.
- WyoCourses WyoCourses is the University's on-line supplemental course website. If you have difficulties with WyoCourses at any time during the semester, click on the Help button at the bottom of the navigation bar on the left-hand side of the page; you can talk to the Canvas Help Desk 24/7 by phone or chat room.
- Microsoft Word The action papers must be submitted in an electronic format in Microsoft Word. Paper copies or electronic files in electronic formats other than Microsoft Word will not be accepted.

General Requirements/Expectations

Required Examinations and Assignments: Students will be expected to complete a series of assignments, including discussion boards, written papers, and quizzes over the material covered in the course. Each week of the course begins on Monday at 12:01 am and ends Sunday evening at 11:59 pm. Assignments are to be completed and/or submitted by Sunday evenings at 11:59 pm of the week in which they are due.

- Quizzes Five quizzes are scheduled as part of this course. The first quiz covers week one and two of the course. The remaining quizzes cover three week segments of the course. There will be no final or comprehensive exam. The quizzes will be taken on-line using WyoCourses. See the Course Chart for the due dates for the quizzes. Each quiz will cover the material from the textbook, the presentations, resource materials, evidencebased practices, and APA formatting. Each quiz will be composed of 30 to 35 questions.
- Discussion Boards Students will complete three discussion boards during the course. Initial threads are due on Tuesday evening, and responses are to be posted over the next five days. See the syllabus attachment titled Discussion Boards for specific details about the discussion boards.
- Research Paper Over the course of the semester, students will complete one research paper evaluating the criminal justice system of a country other than the USA. For details, see the syllabus attachment titled Research Paper.
- Attendance/Participation Ten percent of the grade for this course is based on attending and participating in the weekly Zoom conference calls. Attendance will not be taken during class; instead, five attendance quizzes will be used to assess attendance and participation. A quiz will have one question for each week covered by the quiz. (So, a quiz covering three weeks of the course will have three questions.) The questions will be about what was discussed in class. Students may formally elect to not attend class. They will be expected to complete an alternative writing assignment a research paper on a

topic approved by the instructor. Students must notify the instructor by the end of the first week of class if they wish to opt out of attending the Zoom conference calls.

Required Participation Outside of Class Meetings: Students are not required to participate in organized meetings or activities outside of class.

Final Examination: There is no formal, comprehensive final for this course. The class will not meet during finals week.

Grading Scale and Grading Policies: The final grade for the course will be based on the weighted points accumulated over the course of the semester. The points received for an

assignment will be multiplied by the assigned weight. Quizzes are taken on-line and the scores are available as soon as the quiz is completed. Written assignments will normally be graded within seven days of the due date.

The final grade is based on the total weighted points earned throughout the semester. Grades are awarded as follows: A - 90 or more weighted points, B - 80 to 89 weighted points, C - 70 to 79 weighted points, D - 60 to 69 weighted points, and F - less than 60 weighted points.

Extra Credit: An extra credit assignment is provided. It consists of taking an on-line quiz about proper use of the APA style of formatting. Students close to the border between two grades are strongly encouraged to complete the extra credit assignment. The final weighted grade received at the end of the semester will not be rounded up; for example, an 89.4 will be a B and will not be rounded up to an A. Students desiring the higher grade need to complete the extra credit assignment to receive the higher grade.

Late Assignments: Some assignments must be completed by the posted deadline. Others may be turned in up to five days late. No assignments may be turned in more than five days after the due date without an excused absence.

- Attendance & Regular Quizzes Attendance quizzes and regular quizzes may be taken up to five days late. There is a 10% per day late penalty for late submissions.
- Discussion Boards An initial thread for a discussion board is due on Tuesday evening. Late penalties for the thread apply after Tuesday evening; an initial thread posted after the following Sunday evening will receive no points. Responses may be posted for up to five days after the discussion board ends on Sunday evening; late penalties will apply. Participation points are awarded during the week of the discussion board, and may not be made up.
- Research Paper and Optional Paper The research paper and the optional research paper completed in lieu of attending class may both be turned in up to five days late. There is a 10% per day late penalty for late submissions. Placing the wrong file or a corrupted file in a WyoCourses drop box will be considered a submission. A file that

cannot be opened will receive a zero for a grade. Replacing such a file later will result in a deduction based on the number of days the corrected file is submitted after the due date.

Extra Credit Quiz – The extra credit quiz is available to be taken anytime during the semester. The due date is during the week of finals so the extra credit quiz may not be taken late.

Attendance and Excused Absence Policy: Unless students have been formally approved to opt out of attending class by the instructor, attendance is expected. A student can request an excused absence; for what constitutes an excused absence and/or to apply for an excused absence, see <u>UW Regulation 2-108 (Student Attendance Policy)</u>.

Classroom Behavior Policy: Students are expected to behave as they would at work. Act professionally, arrive on time, pay attention, complete work in a timely and professional manner, and treat all deadlines seriously. Students are to be respectful towards classmates and the instructor. Spirited debate and disagreement are to be expected in any classroom and all views will be heard fully; however, personal attacks, offensive language, name-calling, and dismissive gestures are not warranted in a learning atmosphere. Students who misbehave may be dismissed from the classroom, study sessions, electronic forums, and other areas where disruptive behavior occurs. Electronic devices such as mobile phones should be set to silent or turned off. Laptops are allowed for note-taking purposes. No video or audio recording during class is allowed to protect the privacy of other students.
