Subject: Political Campaigns and Electioneering Activities on Campus

Number:

I. PURPOSE

To outline University of Wyoming policies and procedures regarding political campaigns and electioneering activities on campus.

II. POLICY

<u>In contrast, wWhen a candidate or a candidate's supporters want to reserve Uuniversity facilities for exclusive use related to the a campaign, please keep the following in mindthe following applies:</u>

- A. UW Regulation 6-4 (<u>Use of University Buildings</u>, <u>Grounds and Services</u>) allows use of <u>U</u>university facilities by external parties or individuals for "political campaigning by, or for, candidates who have filed for public office" or "for ballot measures" only with the expressed written authorization of the UW <u>P</u>president or the <u>P</u>president's designee. Persons who have publicly announced their candidacy, even if they have not filed, should be considered candidates and thus fall under the provisions of <u>this</u>—UW Regulation <u>6-4</u>. <u>Here is a link to the regulation: http://www.uwyo.edu/regs-policies/_files/docs/regulations-2021/uw_reg_6</u> <u>4_approved_6-16-21.pdf</u>
- **B.** External users may be assessed fees, charges, and deposits for use of <u>U</u>university facilities. External users may use designated bulletin boards to advertise their events.
- **C.** UW students, faculty, staff, and recognized student organizations (RSOs) are considered external users under UW Regulation 6-4 when acting in a capacity as private citizens or in a manner unrelated to <u>Uuniversity</u> purposes, —such as campaigning for a candidate or hosting events at <u>UW-the University</u> for such a candidate.
- **D.** University facilities do not include the common areas of campus which typically are not reserved for use, such as Prexy's Pasture.
- **E.** The Wyoming Union schedules and rents breezeway tables through its **Ee**vents **Oe**ffice. In accordance with UW Regulation 6-4, the President has approved the use of Union tables and rooms by political candidates and candidate campaign groups, subject to the Union's rules. As such, no specific approval from the President is necessary for

use of Union tables and rooms; however, registration and standard charges established for external users may be applicable.

- **F.** If contacted by a political candidate or an organization that seeks space in a building or facility under your authority, <u>I recommend you</u> direct the requestor to the Wyoming Union Coordinator at 766-3161 to schedule space in the Wyoming Union. As noted above, the use of other facilities requires specific <u>UW</u> University presidential approval.
- G. As a starting point, Ceandidate forums, candidates visiting UW the University on their own to meet with members of the Uuniversity community, and general course discussions typically do not raise issues of concernunder this policy. This memo should not be interpreted as applying to these types of activities. Nor should this memo be perceived as This policy does not limiting a candidate's ability to interact with students, staff, and faculty in public areas of campus. Candidates have rights, just like the rest of us.
