Programme:	Global Biodiversity Information Facility
Objective:	GBIF—the Global Biodiversity Information Facility—seeks concept notes from eligible organizations in sub-Saharan Africa for project funding through the Biodiversity Information for Development (BID) programme.
Eligible Activities:	Concept notes should describe projects that support biodiversity data mobilization by: • Making existing sources of biodiversity data accessible through GBIF to address knowledge gaps and meet regional information needs • Enhancing institutional, national and regional capacity for managing and using biodiversity information • Supporting the application of biodiversity data in support of research and decision-making • Developing and strengthening sustainable institutional, national, and regional partnerships for biodiversity data sharing and reuse Actions must take place in Sub-Saharan Africa. Two types of grants are available: 1. Institutional-level biodiversity data mobilization grants Purpose: Strengthen institutional capacity and mobilize policy-relevant biodiversity data Funding: Up to €30,000 Implementation Period: 24 months 2. Multi-institutional biodiversity data mobilization grants Purpose: Build or strengthen collaborations between institutions to mobilize data for research and policy addressing national or regional priorities Funding: Up to €60,000 Implementation Period: 24 months
Eligible Applicants:	Eligible are legal entities (e.g. research institutions, universities, museums, non-governmental organizations or government agencies) registered in eligible sub-Saharan Africa countries.

Call Title:	DISCOVERY GRANTS
Programme:	Wild Animal Initiative
Objective:	Wild Animal Initiative's Discovery Grants program provides funding for projects that expand the evidence base of wild animal welfare, with a focus validating methods and applying them to new systems.
Eligible Activities:	Each Discovery Grants call solicits project proposals within broad themes aligned with Wild Animal Initiative's research priorities. They expect successful projects to

	be highly cost-effective, with funds primarily supporting uniquely welfare-relevant activities. Actions can take place worldwide.
Eligible Applicants:	Discovery Grants are available to anyone, but we are especially interested in supporting early career researchers (postdocs and PhD students) pursuing a long-term research career in wild animal welfare, or established researchers who seek to expand their research portfolio to include wild animal welfare. If a project is managed by an NGO, that NGO must be registered in the country where field work will take place.

Objective:	UNOPS has just launched the Eco-Innovation Challenge — a global call for innovators with ideas to tackle one of the world's most pressing environmental challenges: pollution in the Black Sea.
Eligible Activities:	The initiative invites participants from any World Bank-eligible country to bring forward solutions that address four major sources of marine pollution: • Agricultural runoff • Municipal Wastewater • Industrial pollution • Marine litter Actions must take place in Georgia, Moldova, or Türkiye.
Eligible Applicants:	The Eco-Innovation Challenge is designed to support both those ready to implement solutions and those who are just beginning to shape their concepts. By combining funding with expert mentorship, the Challenge aims to accelerate innovative responses to marine pollution and foster stronger collaboration across the region.

Call Title:	IPA Soft Skills Research Fund
Programme:	Innovations for Poverty Action
Objective:	The Entrepreneurship and Private Sector Development (EPSD) Program at Innovations for Poverty Action (IPA), with support from the Wellspring Philanthropic Fund has launched a new competitive fund to support rigorous

	research that explores how soft skills influence entrepreneurship and employment-related outcomes.
Eligible Activities:	This opportunity aims to overcome challenges such as unclear identification of skills being studied, lack of comparability across projects, and limited focus on implementation details. Applicants are encouraged to address key evidence gaps, align with a shared framework for measuring soft skills and economic outcomes, and generate actionable insights for implementers and policymakers. Eligible projects must be based in low or middle-income countries and use standardized labor market outcome measures for comparability. They should align with a shared soft skills framework, share implementation details through progress reports, collect cost data, and make de-identified data publicly available within two years of endline collection. The selected projects must also disseminate results publicly through working papers, policy briefs, blogs, or website summaries. Additional selection criteria emphasize experienced, multidisciplinary research teams, including economists, psychologists, educators, and local researchers. Studies should examine wellbeing, mental health, and long-term employment data, assess soft skills across multiple rounds, collect participant feedback, and ensure psychometric rigor in measurement tools. Preference will be given to teams that demonstrate strong implementation commitment, openness to scale-up, and willingness to share training curricula and data for broader analysis. The deadline to submit Expression of Interest forms is November 14, 2025, at 11:59 pm EST. Accepted teams will be invited to submit full proposals by January 30, 2026, with notifications expected by April 1, 2026.
Eligible Applicants:	The initiative welcomes proposals from qualified research teams with at least one PhD holder or PhD candidate affiliated with a recognized research institution. Teams must demonstrate experience in conducting field research and applying impact evaluation methods. The call supports diverse study types, including qualitative and exploratory work, pilot studies, data analysis, nimble impact evaluations, supplementary funding for ongoing trials, longitudinal studies, and full randomized controlled trials.

Call Title:	Research-Practice Partnerships: Collaborative Research for Educational Change
Programme:	Spencer Foundation
Objective:	The Spencer Foundation is accepting proposals for its Research-Practice Partnerships (RPP) program, an initiative designed to foster long-term collaborations between academic researchers and education practitioners.
Eligible Activities:	This program aims to bridge the divide between research and practice by supporting partnerships that co-develop and study solutions to critical educational challenges in authentic settings.

	The RPP program funds projects that generate useful, actionable knowledge for improving education while strengthening the capacity of both researchers and practitioners to work together. Grants of up to USD 400,000 are available for projects lasting up to three years, providing sustained support for research, partnership-building, and implementation. The program prioritizes projects that demonstrate mutual benefit, shared governance, and a clear plan for long-term collaboration. Through this opportunity, the Spencer Foundation continues to promote the co-creation of knowledge that is grounded in real-world practice and informed by rigorous research. The RPP program provides a platform for partnerships that strengthen educational systems, inform policy, and advance equitable, evidence-based improvements in teaching and learning.
Eligible Applicants:	Eligibility for this grant requires that proposals focus on research and related activities that advance collaborative partnerships between academic researchers and a wide range of educational practitioners. Principal Investigators (PIs) and Co-Principal Investigators (Co-PIs) must have either an earned doctorate in a relevant field or equivalent professional experience suitable for this program. If the practitioner or policymaker partner does not hold a doctorate, they must demonstrate professional expertise and leadership experience in their domain. Graduate students may be part of the research team but cannot serve as PI or Co-PI. The PI must be affiliated with a non-profit or public institution capable of administering the grant. This includes universities, school districts, research institutions, and non-profit organizations with recognized 501(c)(3) or equivalent status. The administering PI may represent either the research or practitioner side of the partnership, but there must be at least one Co-PI from the partner organization to ensure balanced collaboration. Proposals are welcome from both U.S. and international applicants, and all submissions must be written in English with budgets presented in U.S. dollars. The Spencer Foundation does not provide grants directly to individuals, and each PI or Co-PI may only hold one active Spencer research grant at a time.

Programme: JAPAN FUND FOR GLOBAL ENVIRONMENT (JFGE)	
Objective:	Objective The Japan Fund for Global Environment (JFGE) was established in 1993 and aims at the promotion and support of environmental conservation. The JFGE is supported by the government's endowment, individual donations and corporate contributions in support of NGO activities.
Eligible Activities:	It funds: Activities for environmental conservation implemented in developing areas by non-governmental organizations (not-for-profit organizations engaged in

	activities on their own initiative) with their primary office in Japan, conducted in response to the needs of the local communities or non-governmental organizations in these areas, and that fall under any one of the following categories: • Implementing local afforestation projects, projects to support the protection and propagation of wildlife, projects to prevent pollution arising from daily activities or other similar projects, to be carried out in developing regions with the participation of the local communities. • Providing, through training or any other methods for local communities, the knowledge required for the implementation of local afforestation projects, projects to support the protection and proliferation of wildlife, projects to prevent environmental pollution arising from daily activities or other similar projects, to be carried out by local residents in developing areas. • Conducting research or holding international conferences to promote such activities • Activities for environmental conservation implemented in developing areas in response to the needs of local communities, and that are applicable to any one of the preceding paragraphs a, b or c, carried out by non-governmental organizations with main offices in areas other than Japan. • Activities carried out by non-governmental organizations with main offices in Japan for the purpose of promoting environmental conservation in Japan, and that fall under any of the categories described below: • Tree and grass planting projects, material collection projects for recycling resources and other projects that are significantly meaningful to or will be executed with the participation of a broad range of the Japanese population. • Raising awareness and dissemination of knowledge related to environmental conservation targeted at a broad range of the Japanese population. Actions can take place in developing countries.
Eligible Applicants:	Applications are eligible from nonprofit organizations implementing environmental conservation activities in developing countries. They must have an agent (organization or individual) that has a bank account in Japan and can communicate with JFGE about the project both verbally and written in Japanese.

Call Title:	Lloyd's Register Foundation's Heritage Grants
Programme:	Lloyd's Register Foundation
Objective:	The Lloyd's Register Foundation has launched an open call for its Heritage Grant, inviting ambitious and high-impact projects that strengthen research, equity, safety, and public access in heritage management.

	This £2.5 million scheme seeks proposals that explore how history can inform safer, more inclusive futures—especially in maritime and coastal realms—while emphasizing cross-disciplinary collaboration and innovation.
Eligible Activities:	Projects must align with one or more of the foundation’s heritage themes—such as maritime safety, transitions in maritime or port technology, or uncovering hidden histories—and should integrate equity, public access, and future-oriented learning. The foundation is particularly keen to support scalable initiatives that build capacity across the heritage sector, promote inclusive storytelling, and open access to heritage knowledge. Grants are expected to range between £200,000 and £500,000 per project, with flexible project durations. Eligible costs include research, public engagement, capacity building, digital innovation, and specialist equipment (pre-approved). Applicants are not permitted to use funds for capital works, tuition fees, lobbying, or retrospective costs, among other restrictions. Shortlisted applicants will be invited to develop full proposals, with final awardees to be announced in June 2026. Throughout their work, grantees will be expected to share insights publicly, engage in learning, and adhere to governance, reporting, and evaluation requirements. This opportunity offers heritage professionals and organizations a vital avenue to reimagine how history and cultural memory can foster education, safety, inclusion, and innovation—linking the past to future resilience.
Eligible Applicants:	Applicants from a wide variety of organizations—academia, museums, cultural institutions, civil society, and private sector entities with public interest missions—are welcome to apply. The foundation encourages partnerships that span sectors, geographies, and disciplines, giving space to new voices and underrepresented narratives.

Programme:	OCKENDEN INTERNATIONAL
Objective:	Ockenden International is looking for projects, activities and/or programmes (each 'a project') which promote self-reliance among refugees and/or displaced people. You can enter a project run by your organisation or you can nominate a project managed by a non-profit partner or affiliated organisation. In these Entry Rules, 'the organisation' refers to the organisation which manages the project. The project must benefit refugees and/or displaced people with a strong emphasis on promoting self-reliance.
Eligible Activities:	The primary focus of the project must be helping refugees and/or displaced people in need, rather than this being an ancillary benefit. The organisation must be able to show that the project has been effective with measurable evidence of positive outcomes. The judges will, in particular, look for: • Projects that promote self-reliance among refugees and/or displaced people. These may be projects that are led by or have a high level of participation from displaced people themselves; projects providing education, legal assistance and/or livelihood assistance; or any other programmes that help refugees and/or displaced people build stable, independent lives. • Projects that have proved to be highly effective in improving the lives of refugees and/or displaced people. • Projects that have led to real change in the lives of refugees and/or displaced people. • Effective initiatives, with measurable evidence of outcomes. Actions can take place worldwide.
Eligible Applicants:	Projects, activities and/or programmes are eligible.

Call Title:	Ibsen Scope Grants
Programme:	Ibsen Scope
Objective:	The Ibsen Scope Grants award innovative projects in drama and performing arts that engage with existential, social, and society-related themes. Created by the Norwegian government, these grants support individuals, theatre groups, organizations, or institutions that pursue critical artistic discourse. Grantees must submit applications by a specified deadline, following the established rules and guidelines. A jury—appointed by the Norwegian Ministry of Cultural Affairs in collaboration with Teater Ibsen—evaluates proposals and selects recipients based on artistic merit, relevance to Ibsen’s themes, and capacity to stimulate meaningful conversation.
Eligible Activities:	Funded projects typically lead to theatre performances, creative works, or interdisciplinary explorations that reinterpret or engage with Ibsen’s legacy for contemporary contexts. The public presentation of awarded works often becomes part of the Ibsen Scope Festival, offering visibility and recognition to recipients. The grants are administered and overseen by Teater Ibsen, which handles application logistics, jury facilitation, and reporting of public fund usage. The total program budget for grants is approximate NOK 2,000,000, supporting multiple projects across different countries and contexts in any given year.
Eligible Applicants:	Applications are open to a wide range of creators: individual artists, theatre companies, organizations, and institutions. The program continues to encourage work that not only pays homage to Ibsen’s dramatic legacy but also inspires artistic inquiry into pressing social issues through performance, interpretation, and innovation.

Call Title:	ERC CONSOLIDATOR GRANT
Programme:	European Commission (EC) - HORIZON
Objective:	The ERC Consolidator Grants are designed to support excellent Principal Investigators at the career stage at which they may still be consolidating their own independent research team or programme.
Eligible Activities:	Principal Investigators must demonstrate the ground-breaking nature, ambition and feasibility of their research proposal. A competitive Consolidator Grant Principal Investigator should have already shown evidence of research independence. Actions must take place in EU member states or Associated Country.

Eligible Applicants:	The ERC actions are open to researchers of any nationality who intend to conduct their research activity in any EU Member State or Horizon Associated Country. Principal Investigators may be of any age and nationality and may reside in any country in the world at the time of the application. The host institution must engage and host the Principal Investigator for at least the duration of the project, as defined in the grant agreement.

Call Title:	Support for Information Measures Relating to the Common Agricultural Policy
Programme:	European Commission (EC)
Objective:	The European Commission is inviting proposals for the 2026 call under the Support for Information Measures relating to the Common Agricultural Policy (IMCAP), aiming to increase awareness about the CAP among citizens, farmers, and other stakeholders. The projects must use objective and measurable (quantitative and qualitative) impact indicators for their proposed objectives and activities that will be assessed by an impact evaluation methodology. These indicators should include inter alia: the baseline (i.e. a description of the current levels of awareness and perception of the CAP amongst the targeted audience). This could be based on Special Eurobarometer 520 data or other objective and credible data sources that define the levels of awareness and perception about the CAP in a particular target audience, the total number of contacts expected to be made during the communication and information activities, and the targeted increase in the total number of contacts who recognise and/or have a more positive opinion of the CAP as a result of the information and communication activities (in relation to the baseline).
Eligible Activities:	The general objective of this call is to raise awareness about the Common Agricultural Policy (CAP) within the EU, amongst all citizens, farmers, and non-farmers alike, and to disseminate information about the CAP in full compliance with the Commission's legal requirement under Article 46 of Regulation (EU) 2021/2116. The measures aim to help citizens understand how the CAP responds to challenges in agriculture and food production, restores consumer confidence after crises, supports rural development, and promotes a competitive, sustainable, and resilient EU agricultural model. They also aim to inform citizens about the CAP's role in preserving biodiversity, mitigating climate change, supporting farmers' income, and encouraging a sustainable approach to European agriculture. The proposals should focus on the ten specific objectives of the CAP, considering Member States' CAP strategic plans, the Action Plan for the Development of Organic Production, the Common Market Organisation, the Unfair Trade Practices Directive, and the Political Orientations for the 2024-2029 European Commission. Proposals must provide coherent, objective, evidence-based information measures reaching a significant number of citizens, thereby raising public awareness about EU support to agriculture and rural development.

	Eligible activities include production and distribution of print, multimedia, or audiovisual material, web and social media outreach, media events, conferences, seminars, workshops reaching large audiences, and CAP-related studies if required. Activities not eligible include those required by law, statutory meetings, or any activity where communication and information are not the main focus. Projects with previous co-financed campaigns must describe their past impact and explain the novelty of their proposed activities for this call. The call has a total indicative budget of EUR 4,000,000. Proposals can be submitted as IMCAP Project Grants or IMCAP Action Grant Budget-Based models.
Eligible Applicants:	The target public for the themes is the general public (in particular young people in urban areas) and/or farmers and other stakeholders active in rural areas and the agricultural sector. For young people in urban areas, school children, teachers and university students: new approaches should be used to engage with young people and raise their awareness of the new CAP and the contribution that it makes in many areas such as the climate change challenge, food, healthy and high quality eating as a lifestyle choice, in relation also with the EU School Scheme for Milk, Fruit and Vegetables and the Tartu Call. For stakeholders: stakeholders should be more aware of the contribution that the CAP makes to support the social, environmental and economic sustainability of agriculture.

Call Title:	Women Entrepreneurship for Africa Programme
Programme:	TEFConnect
Objective:	The IYBA-WE4A (Investing in Young Business in Africa- Women Entrepreneurship for Africa) Entrepreneurship Programme is designed to empower women entrepreneurs in Sub-Saharan Africa by enhancing their access to finance and business knowledge. The focus areas of the programme include empowering women entrepreneurs in Sub-Saharan Africa, enhancing their access to finance and business knowledge, promoting green businesses, and driving economic inclusion, job creation, and sustainable development.
Eligible Activities:	The IYBA-WE4A Entrepreneurship Programme is delivered in five phases: the Application Phase, Training Phase & Masterclass Sessions, Mentorship Programme, Business Plan, Financials & Pitch Video Submission, and the Seed Capital Phase. During the Application Phase, which runs from October 6, 2025, to January 25, 2026, applicants must complete an online form on TEFConnect, including personal information, business details, business acumen assessment, industry-specific questions, and declarations. Applicants must also submit a valid government-issued ID and a recent headshot photo. Eligibility notifications are sent on-screen and via email, guiding applicants on the next steps of the programme. Shortlisted participants enter the Training Phase, gaining access to a customised Business Management and Green Business curriculum. Completion of all training

	modules, multiple-choice assessments, and participation in cluster engagement groups are mandatory to progress. Following training, participants submit a business plan, financials, and a 2–3-minute pitch video, using the skills acquired during the programme. Submissions are reviewed and scored by a third-party consultant, who provides feedback and confirms eligibility for the next phase. In the Seed Capital Phase, participants are required to register their business (if not already registered), open a verified business bank account, and submit valid documents including government-approved ID, business registration certificate, tax registration evidence, bank reference letter, partner's consent form (if applicable), and medical report (if applicable).
