Objective:	<p>The AI for Climate Resilience Program is a new initiative by Klarna that aims to support pioneering projects that leverage artificial intelligence for climate adaptation in underserved, climate-vulnerable regions.</p> <p>The program will back projects that help local communities adapt to a changing climate and build long-term resilience. This includes for example strengthening food security, enhancing health systems, and building coastal resilience in regions that are particularly vulnerable to climate impacts.</p>
Eligible Activities:	<p>Outcomes</p> <p>They aim to support projects that deliver on one or several of the following types of outcomes:</p> <p>Harness and elevate local knowledge. Discern, organize, and analyze community insights to generate concise, actionable information accessible both to large-scale actors (e.g. governments, NGOs) and the very communities that contributed it.</p> <p>Develop and demonstrate novel AI applications in real-world settings—such as smartphone-based AI advisers for smallholder farmers to enhance resilience, or AI-powered climate-risk assessments for low-lying islands to inform infrastructure planning and relocation strategies.</p> <p>Improve and enhance adoption, cost-effectiveness or sustainability of existing AI solutions for climate adaptation and resilience, including advancing ecosystem-wide knowledge by contributing open datasets, benchmarks, or best-practice insights that benefit the broader AI-for-adaptation community.</p>
Eligible Applicants:	<p>Eligibility Criteria</p> <p>The basic requirements that a project or proposal must meet to be considered for funding, support, or participation:</p> <p>Strategic alignment: The proposal addresses a concrete climate-impact challenge in line with the outlined focus for the call.</p> <p>Implementation-focused: The team will adapt, localize, scale or otherwise deploy a concrete solution; no “research-only”.</p> <p>Use of AI: The proposed use of AI has clear potential, is collaborative, and responsible. There should be a clear, compelling rationale for its use, demonstrating how AI directly contributes to addressing the project’s objectives. They also welcome early-stage applications from teams that need support in developing technical details further.</p> <p>Geographic focus: The project is supporting underserved, climate-vulnerable communities in low- and middle-income countries.</p> <p>Public-benefit purpose: The project must be committed to a public-benefit purpose, ensuring its outcomes primarily serve the public interest with tangible social and environmental benefits. For-profit entities must demonstrate how their project aligns with public-benefit goals and how they will ensure equitable outcomes that directly support local communities.</p>

Objective:	<p>The Anusandhan National Research Foundation has announced call for proposals for the new program PM Professorship, to utilize the expertise of superannuated scientists and faculty from reputed academic institutions, research laboratories and industry, who are willing to serve in the state universities where research is still at nascent stage.</p> <p>Prime Minister Professor is expected to mentor faculty and students of less endowed universities to improve/raise their research eco-system to be world class.</p>
Eligible Activities:	<p>Objective</p> <p>Leveraging expertise of active, eminent and superannuated scientists for their outstanding contributions both nationally and internationally in the areas of engineering, science, and technology including agriculture, medicine and social sciences at the interface of science and technology. The program aims to strengthen R&D culture in less endowed state universities, by boosting their research and innovation aspects in collaborative mode.</p> <p>Funding Information</p> <p>A PM professor will receive a fellowship of Rs. 30 lakh (p.a.) plus Rs. 24 lakh as research grant (consumables, domestic travel, contingencies, minor equipment</p>

Also, an overhead of a fixed amount of Rs.1 lakh per year will be provided under the program.</p> <p>Host university should demonstrate commitment to provide office space, laboratory, library facilities, etc. to the PM Professor.</p> <p>The tenure of the PM Professorship will be 5 years. Performance review after 3 years by the expert committee constituted for the purpose.</p> <p>Responsibilities of the Prime Minister Professor</p> <p>Enhancing the Research and Innovation capabilities of target host universities.</p> <p>Mentoring faculty and students of target universities for pursuing worldclass research in frontier areas of national interest including translational research.</p> <p>Strengthening research and innovation collaborations between established institutions, industry with less endowed universities.</p> <p>Promoting sustainable knowledge exchange.</p>
Eligible Applicants:	<p>Eligibility Criteria</p> <p>Superannuated or retired faculty or scientists from reputed Indian institutions, research laboratories or from private institutions.</p> <p>Overseas scientists i.e. Non-Resident Indians (NRIs), Persons of Indian Origin (PIOs), and Overseas Citizens of India (OCIs).</p> <p>Professionals from industry/experienced Professors of Practice with a distinguished record of research and innovation.</p> <p>Applicants should have strong research credentials, must be actively involved in research and innovation activities, and demonstrate a strong commitment to mentor faculty at the eligible state universities where research and innovation is still at a nascent stage.</p> <p>Eligible host institutions are the state universities that have been qualified as spoke institutions in Category A of the recently awarded PAIR program of ANRF. To view the eligible host institutions,</p> <p>Applicants must be willing to relocate to the proposed host institution on full time basis and should have a proper plan to contribute significantly to the development of its research capabilities and innovation culture.</p> <p>Evaluation Criteria</p> <p>A joint proposal must be submitted by the superannuated or retired faculty member/scientist/industry professional or Professor of Practice in collaboration with the various departments from the proposed host university. It should also include plans to encourage and guide faculty and students in undertaking world-class research and innovation projects having potential to significantly impact the academic and research environment of the host university.</p> <p>Mentor has to collaborate with head of university/various departments willing to participate and work out the plan for raising the R&D ecosystem of the host university.</p> <p>Mentor may also contribute to establish a research lab in a specific department or common research facility in the host university, with the research/infrastructure fund or from Corporate Social Responsibility (CSR) fund of the institute, subject to the approval of the head of the institution.</p>

	<p>Proposals will be evaluated by a designated selection committee based on the academic and professional credentials of the applicants with distinguished records and exceptional contributions in the fields of engineering, science, and technology (including agriculture, medicine and social sciences at the interface of science and technology) as well as the potential merit, novelty, and innovativeness of the approach of raising the target institution's research ecosystem to globally competitive standards.</p> <p>Performance of the faculty in the proposed departments (to promote interdisciplinary approach in research activity) during the last 5 years w.r.t. publications in SCI journals/patents, awards received by the faculty members, past/present projects with govt. agencies, consultancy provided, collaboration & impact will be evaluated.</p> <p>Proposal should include a projected research plan/activity for next five years. Proposals for mentoring the faculty with their ongoing projects leading to the development of prototype/patents will be encouraged.</p> <p>Details of research facilities and number of manpower available including no. of faculty members with PhD degree and number of research scholars with the proposed departments of the host institute to carry out the proposed activity. Call Title:		FELLOWSHIPS FROM CANON FOUNDATION
Programme: Canon Foundation in Europe		
Objective:	The Canon Foundation in Europe is a philanthropic, grant-making institution, active in the promotion of international culture and scientific relations between Europe and Japan. It was founded in 1987 under Dutch law and has its Secretariat in Amstelveen in the Netherlands. Its objective is the promotion of science, culture know-how and mutual understanding between Europe and Japan. Annually, the Canon Foundation in Europe grants up to 15 Fellowships to highly qualified European and Japanese researchers. European Fellows are expected to pursue a period of research in Japan whereas Japanese Fellows are expected to do their research in Europe. Canon Foundation Fellowships are for a minimum period of three months up to maximum of one year. They support all fields of research. There are no limitations or restrictions. Applicants do not have to be currently enrolled or employed at the time of applying.	
Eligible Activities:	Canon Fellows from Europe are free to choose their host institutes and hosts in Japan. The same freedom is given to Japanese Canon Fellows coming to Europe. Canon Foundation Research Fellowships may be applied for when an agreement on co-operation and on a research plan has been reached between the guest researcher and the proposed host institution. Applications can also be submitted by members of commercial, industrial, governmental or professional organisations. European countries are eligible as well as Japan.	
Eligible Applicants:	All Europeans are eligible to apply (including Israel, Turkey, Balkan and Baltic countries). Applicants should have obtained at least a Master’s or PhD degree within the last ten years of applying to the Canon Foundation. They will also consider candidates who obtained their qualification more than ten years ago as long as they provide further supporting information in their application. Please note that priority is given to applicants going to Europe and Japan for the first time.

	<p>Nominees can come from any field related to the study of the human past, both within academia and outside it.</p> <p>They are looking for researchers in disciplines such as history, archaeology, art history, digital humanities and human palaeontology, as well as independent scholars, public historians, museum curators and documentary filmmakers.</p> <p>Anyone can nominate, self-nominations will not be considered. Renominations from previous years are encouraged.</p> <p>Nominees for the Dan David Prize:</p> <p>Must be engaged in outstanding and original work related to the study of the human past, employing any chronological, geographical and methodological focus.</p> <p>Should exhibit strong potential for future excellence, innovation and leadership that will help shape the study of the past for years to come.</p> <p>Academic nominees must hold a PhD and must have published at least one major piece of work, such as a book or a collection of articles related to a major project.</p> <p>Non-academic nominees are not required to hold a PhD, but must have completed at least one major piece of work such as a book, major publication, exhibition, documentary film or public humanities project. They should also demonstrate an ongoing engagement with topics related to history and the study of the past.</p> <p>Should be no more than 15 years post-PhD (for academics) or 15 years after the release of their first major project (for non-academics), although due allowance will be made for career breaks (e.g. parental and care leave or duties, health-related leave and career changes).</p> <p>Nominators will be asked to provide the nominee's CV and list of relevant work or publications, and to answer a few brief questions.</p> <p>The Dan David Prize is awarded on the basis of merit, regardless of gender identity and expression, sexuality, race, ethnicity and nationality, religion, age, ability or political affiliation.</p>

Programme:	"la Caixa" Foundation
Objective:	<p>The "la Caixa" Foundation has launched the Postdoctoral Fellowships Programme aimed at recruiting outstanding researchers of any nationality who wish to further their careers in STEM disciplines (Science, Technology, Engineering, and Mathematics) in Spain or Portugal.</p> <p>The programme targets experienced researchers with an exceptional track record, demonstrated through the originality and impact of their scientific contributions. Candidates should also show strong leadership potential, with the capacity to lead their own research group in the future</p> <p>In addition to supporting scientific excellence, the fellowships offer a comprehensive training programme that integrates scientific, technical, and transferable skills. This initiative aims to foster the development of fellows as independent researchers and future leaders in the scientific community.</p>

<p>Eligible Activities:</p>	<p>The "la Caixa" Foundation is offering 20 three-year postdoctoral fellowships to recruit experienced researchers to carry out their projects at any university or research centre of Spain or Portugal. The research must be carried out in the research areas of Science, Technology, Engineering and Mathematics (STEM), including Bio and Health Sciences. The call for applications is intended for researchers who finished their doctoral degree two to seven years prior to the application deadline and fulfil the requirements for mobility between countries.</p> <p>Funding Information</p> <p>The maximum payment amount will be €€320,100, broken down as shown below:</p> <p>Three maximum annual payments of €102,500 which include:</p> <p>Labour costs (salary included): a maximum of €64,000 to cover the total labour costs of the host institution hiring the fellow.</p> <p>In any case, the minimum annual gross salary to be offered to the fellow by the host institution must be €47,000.</p> <p>Annual research project costs of €38,500, which include:</p> <ul style="list-style-type: none"> Purchase and maintenance of scientific equipment and consumables; Travel expenses and daily allowance; Registration fees for scientific congresses, seminars and conferences; Management fees for industrial and intellectual property rights related to the project; Patenting costs; Personnel hiring costs linked exclusively to the fellowship project; Expenses related to the mandatory secondment; Overheads; Other expenses directly related to running of the research project. <p>Gross annual family allowance of €1,200 for each of the researcher's dependent children.</p> <p>Mobility allowance (moving and housing) of €5,400 gross to be paid at the start of the fellowship if the fellow changes the host institution to carry out the postdoctoral Junior Leader fellowship and this change implies a moving of the place of residence.</p>
<p>Eligible Applicants:</p>	<p>Eligibility Criteria</p> <p>Nationality:</p> <p>Postdoctoral researchers of any nationality are eligible to apply for the postdoctoral Junior Leader Fellowship–Retaining programme.</p> <p>Research training:</p> <p>Those who obtained their doctoral degree (PhD) two to seven years prior to the application deadline are eligible. For such purposes, candidates must have obtained their doctoral degree between 25th September 2018 and 25th September 2023, both inclusive. The date of the defence for the doctoral thesis will be understood as the date the doctorate (PhD) was obtained. Therefore, a document must be provided where the date of the thesis defence is certified.</p> <p>In the event of an interruption of the research activity between the date of obtaining the doctoral degree and the call deadline (25th September 2025), the period in which the doctoral degree must have been obtained may be extended beyond seven years on the following causes:</p> <p>Illness or accident that led to sick leave of three months or more. An extension may be given for the duly justified number of months.</p>

	<p>Maternity. An extension of 1 year can be given for each child born after the PhD defence date. If the candidate can justify longer maternity leave, the eligibility period will be extended to cover the documented leave taken until the call deadline.</p> <p>Paternity. An extension of 1 year can be applied for each child born after the PhD defence date.</p> <p>Compulsory National service: An extension may be applied for the demonstrated number of months.</p> <p>Mobility:</p> <p>Candidates who wish to join a Spanish centre or university must have resided or have carried out their main activity (work, studies, etc.) in Spain for more than twelve months in the three years immediately prior to the application deadline. Those candidates who wish to join a Portuguese center or university must have resided or have carried out their main activity (work, studies, etc.) in Portugal for more than twelve months in the three years immediately prior to the application deadline. Short stays, such as holidays, in a country other than their usual country of residence (where they carry out their main activity), will be considered as time spent in their usual country of residence.</p> <p>A candidate with an uninterrupted period of at least 2 years of inactivity in research (e.g. unemployment, periods of employment outside research, parental or long-term sick leave) must have resided or carried out the main activity (work, studies, etc.) in Portugal for more than 36 months in the 5 years immediately before the call deadline.</p> <p>International stays:</p> <p>For candidates applying to carry out the research in a Spanish university or research centre, the candidate must have carried out research stays at non-Spanish research centres or universities during their doctorate or postdoctorate, whether of a continuous or discontinuous nature for at least six months prior to the deadline for applications.</p> <p>Selection Criteria</p> <p>The process is comprised of three parts:</p> <p>Eligibility check: all applications received are screened to ensure that they comply with formal requirements.</p> <p>Shortlisting: each eligible application is sent to an evaluation panel made up of two to four experts with broad experience in the discipline of the application and an extensive list of publications or contributions within this field.</p> <p>Interviews: The candidates whose applications have passed the remote evaluation stage will be invited for a face-to-face interview.</p>

Objective:	The Central European Initiative (CEI) is glad to announce the opening of the Call for Proposals 2025 in the framework of the Know-how Exchange Programme (KEP)

	with funding made available by the CEI Fund at the EBRD, entirely financed by the Italian Government.
Eligible Activities:	<p>The KEP is a development instrument aimed at supporting the transfer of expertise, best practices and benchmarks from public/private entities in the EU to peers in the non-EU countries within the CEI region. The Programme is primarily aimed at contributing to securing stable, prosperous, and wellfunctioning democratic societies on a steady path towards the EU. By co-financing capacity building and technical assistance projects, the KEP offers grants to help non-EU members to advance towards EU standards and policies. The KEP focuses on areas of intervention where EU CEI countries demonstrate strong-rooted experience, and where beneficiary states exhibit the strongest need for assistance according to the areas of cooperation outlined in the CEI Plan of Action 2024-2026.</p> <p>Funding Information</p> <p>The overall indicative amount for this Call for Proposals is up to a maximum cumulative amount of six hundred thousand euro (600,000 EUR) that will be made available through the CEI Fund at the EBRD, entirely financed by the Italian Government.</p> <p>Any grant awarded under this Call for Proposals shall not exceed fifty per cent (50%) of the total cost of a given project, and the maximum grant amount allocated to a single project cannot exceed forty thousand Euros (40,000 EUR).
