Call Title:	ENDANGERED LANGUAGES DOCUMENTATION PROGRAMME (EDLP)
Programme:	ENDANGERED LANGUAGES DOCUMENTATION PROGRAMME (EDLP)
Objective:	The goal of the Endangered Language Documentation Programme (ELDP) is to support the documentation and preservation of endangered languages globally. To this end they give grants worldwide to individuals to document endangered languages. They provide funding for documentation projects led by individuals such as linguists, linguistic anthropologists and community members with skills in linguistic documentation.
Eligible Activities:	They provide grants for the linguistic documentation of endangered languages worldwide. ELDP Legacy Material Grants are offered to support the digitisation and archiving of legacy materials which are a rich resource for the documentation of the world's linguistic diversity and are in danger of being lost: recordings of endangered or moribund languages in analogue format which are not part of an existing repository. Actions can take place worldwide.
Eligible Applicants:	To apply to their program you need to be affiliated with a host institution such as a university, which is a registered entity and has experience in administering grants. You should have experience in modern linguistic language documentation. Anybody with qualifications in linguistic language documentation can apply as they have no restrictions on the nationality of the applicant or on the location of the host institution. They do not fund revitalisation projects.

Call Title:	Open Call: Advancing Bioengineering in Microgravity Environments
Programme:	European Space Agency
Objective:	The European Space Agency (ESA) invites innovative companies to explore the potential of bioengineering in microgravity environments to develop profitable space-enabled services and products. The primary objective of this Invitation to Tender is to support industry in assessing the potential of bioengineering in microgravity environments, addressing market requirements from various industries, including but not limited to pharmaceuticals, materials science, healthcare, food and nutrients, assessing the customer demand and developing value propositions that resonate with customers and are embedded in profitable business models. Topics of relevance include Tissue Engineering, Biomanufacturing, and Microgravity Bioreactors. ESA seeks promising business ideas addressing attractive market opportunities, identified customer needs and engagement, commercially viable service/product concepts, technically feasible solutions, added value of space microgravity

	environment, and motivated teams with business, technical, and financial expertise.
Eligible Activities:	<p>The initiative centres on leveraging the unique conditions offered by space, particularly microgravity, to advance bioengineering technologies. Tissue engineering focuses on developing artificial tissues and organs for medical applications, while biomanufacturing enables the production of biological products such as pharmaceuticals and food in space environments. Microgravity bioreactors simulate space conditions, allowing researchers to study biological processes with reduced gravitational influence, thereby enhancing the understanding of cell behavior, gene expression, and nutrient transport.</p> <p>ESA has partnered with companies such as SpaceApps through the IceCubes service, Kayser Italia's Bioreactor Express Service, and BioRider for operations and biological sample recovery aboard ESA's Space Rider vehicle. These collaborations enable companies to use microgravity to create new products and services with improved efficiency and quality, fostering commercial growth and scientific breakthroughs.</p> <p>The microgravity environment offers unique advantages, such as the elimination of sedimentation and buoyancy-driven forces, altered fluid dynamics, and decreased shear stress, which can significantly impact bioengineering outcomes. Companies that harness these possibilities can deliver innovative products with superior performance and offer specialised services, including in-orbit experimentation for research and development.</p> <p>ESA provides 200,000 Euros as a firm fixed price covering 100% of the total cost, along with technical and commercial guidance, access to networks and partners, and the use of the ESA brand for proposed services.</p>
Eligible Applicants:	The opportunity is open for enabling studies to develop early user engagement for space services where market rollout is constrained by regulatory or business model challenges. Eligible teams must be based in ESA member states, and authorisation from the corresponding National Delegation is required for funding.

Programme: British Council	
Objective:	<p>The British Council has launched the Women in STEM Scholarships 2026-27, offering opportunities for women from eligible countries to pursue a fully funded one-year master's degree in the UK.</p> <p>The programme contributes to significantly increasing the number of opportunities for women from eligible countries to be able to complete a UK master's degree in the 2026-27 academic year, particularly encouraging women whose identities include multiple intersecting factors, including race, class, and religion, providing the selected scholars with a foundation to launch their careers in higher education and research in their home country, enabling women scholars to promote and enhance science and innovation in their home country through their exposure to the expertise in the UK's renowned STEM research sector, creating strong and lasting connections with the UK through active engagement with Alumni UK network in the UK, directly contributing towards supporting the success of the alumni network and this programme in future iterations of the Scholarship, and providing a platform for the countries included in this call and the UK to work together to address the significant challenge of the global gender gap in STEM.</p>
Eligible Activities:	<p>The scholarships aim to close the gender gap in STEM, where women continue to be underrepresented in research, leadership, and employment despite evidence of high productivity and impact.</p> <p>For the 2026-27 academic year, at least 45 full scholarships will be awarded, each covering tuition fees, living expenses, IELTS exam fees, travel, visa, insurance, study-related costs, and reasonable adjustment support for scholars with disabilities. Each UK institution will host a cohort of five scholars, funded at £200,000, and will also be expected to provide co-funding or in-kind contributions where applicable.</p> <p>Institutions selected to participate must demonstrate commitment to Equality, Diversity, and Inclusion, and ensure comprehensive support for international students throughout their stay. This includes assistance with admissions, accommodation, visa processes, welfare, mentoring, and networking opportunities with industry. Universities will manage applications, shortlist candidates, and work with the British Council on the final selection to ensure geographic representation across the eligible countries.</p> <p>Through this initiative, the British Council continues to build pathways for women to contribute to science, research, and innovation, while strengthening long-term collaborations between the UK and participating countries. Application closes on 24 October 2025.</p>
Eligible Applicants:	<p>Eligibility requires applicants to be women from one of the eligible countries, hold a valid passport, meet the entry requirements of the selected UK institution, demonstrate financial need, and show motivation to pursue a STEM career contributing to socio-economic advancement in their home country. Preference will be given to candidates without prior international study experience.</p>
