



# **RAW DATA FROM:** Rock Springs Resource Management Plan **Public Workshops**

NOVEMBER 17-18, 2023

The raw data contained within this document comes from four public workshops that addressed the Bureau of Land Management's draft Resource Management Plan for the Rock Springs Field Office in Southwest Wyoming. The University of Wyoming and partners, on behalf of Wyoming Govenor Mark Gordon, facilitated these workshops in Rock Springs, Green River, and Farson November 17-18, 2023, in the capacity of neutral convenors.

In each workshop, facilitators asked participants to respond to three prompts. (1) What about these lands is important to you? (2) If you were writing the Resource Management Plan, what would you prioritize to support the things that are important to you? and (3) What advice would you give the task force for how to balance multiple priorities? Notetakers tried to capture verbatim responses and took notes in real time so that workshop participants could see how their statements were captured and correct the statement if they felt it was inaccurate.

A team from the University of Wyoming analyzed these notes and grouped them under major themes. Each statement by a workshop participant could be coded as more than one theme. Below is the complete, raw set of data as the team coded it. "Important:" corresponds with answers to the first prompt. "Prioritize:" corresponds with answers to the second prompt. "Balance:" corresponds with answers to the third prompt.
