JOB PURPOSE:

Draws blood from patients and prepares specimens for screening, analysis, or other medical purposes. Collects all sample specimens and labels accordingly. May assist physician/resident/practitioner with routine medical procedures or provide coverage for other areas.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Assemble equipment, such as tourniquet, needles, disposable containers for needles, blood collection devices, gauze, cotton, and alcohol on work tray, according to requirements for specified tests or procedures.
- Perform phlebotomy and operate equipment under the direction and supervision of the Laboratory Technologist.
- Verify or record identity of patient or donor and converse with patient or donor to allay fear of procedure.
- Calibrate, operate, and safely maintain laboratory equipment, including microscope, centrifuge, chemistry analyzer, immunoassay analyzer and other equipment.
- Prepare appropriate specimens for culture and transport.
- May conduct interviews, take vital signs and draw and test blood samples to screen donors at blood bank.
- Assist with Quality Control for lab equipment and various testing.

- Must have appropriate technical, interpersonal and computer proficiency.

- A graduate of an accredited phlebotomy program and/or must have documented experience as a phlebotomist.

- Safely move up to 100 pounds one-third of the time.
- Work as a team member and foster a cooperative work environment.
- Work with a diverse population.
- Sterilize supplies and equipment; maintain and restock examination and procedure rooms.

WORKING CONDITIONS:

Medical clinic environment; regular exposure to biological and chemical hazards, fumes, vapors, infectious diseases, noise and confined spaces; standing, sitting, reaching, and using hands are regular requirements of the position.
