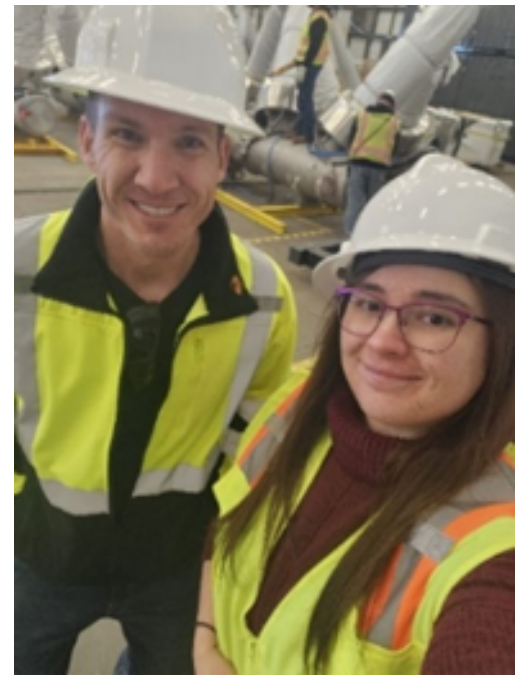
Employer: Takkion
