With only a couple of summer opportunities for internship experience during law school, it is vital to maximize your efforts.

Improve at Least One Legal Skill

Whether you improve your legal writing or learn to effectively research issues, figure out which skills the job can help you improve and then work to accomplish that goal.

Find Out What You Like and Dislike

Use your summer experiences to explore possible career paths. This will help you narrow your search for future legal positions, especially approaching Fall OCI.

Establish a Good Reputation in the Office

One of the goals for the summer is to leave with a glowing letter of recommendation for your next job.

Start Building Your Network

Do not be afraid to ask your boss to help you meet as many people as possible outside of the office.

Get a Writing Sample
