Bar Exam Prep

DO: TAKE BREAKS

Passing the bar exam requires a lot of study time, but you still need time to be a human. Get enough sleep, stay in touch with family and friends, and routinely take breaks to relax.

DON'T: BOTTLE UP STRESS

Studying for the bar exam will probably be one of the most stressful time periods of your life. Seek out healthy outlets like exercise, meditation, or therapy to let out the stress.

DO: PRACTICE PLENTY

The more you practice, the more prepared you'll be for the real exam. Applying your knowledge to questions will help you identify weak spots, get better at thinking on the spot, and become comfortable with different question types.

DON'T: IGNORE THE DETAILS

The days leading up to the exam will be stressful, so do everything you can ahead of time to eliminate the minor headaches. Get familiar with test day protocols and timelines, and take care of things like preparing snacks and selecting clothing that ensures exam-day comfort.
