¹ Civil Procedure II is a 2.0 credit course that will be offered on a compressed schedule in order to lessen the number of first year exams during the regularly scheduled exam period. Civil Procedure II will begin on Wednesday, January 21, 2026, and end on Wednesday, April 1, 2026. The final exam will be held on Friday, April 10, 2026, at 9:00 am.

² Gift and Estate Taxation is a prerequisite for this course.

³ Preference given to 3L standing.

⁴ Students who took Advanced Persuasive Writing last year should NOT take this course. Enrollment in this course is limited to 12 students on a first-come, first-serve basis via registration. If this course is oversubscribed, preference will be given to 3L students for the first week of registration. Additional students will be placed on a waitlist.

⁵ Requires 3L standing. Course will meet in person 2-3 times throughout the semester. Students wanting to enroll in Bar Review <u>and</u> the Family & Child Advocacy Clinic should contact the Law Registrar for a special override.

⁶ This course cannot be taken if you have taken a previous version of Business Organizations or Agency & Partnership or Corporations.

⁷ Offered for a letter grade only. Civil Legal Services clinic enrollment is limited to 8 students; 7 determined on a first-come, first-served basis by registration. New 3L students preferred followed by returning 3L students and then 2L students. If the registration is oversubscribed, additional students will be placed on a waitlist

⁸ Requires 3L standing and approval from Prof. G. Smith, offered for a letter grade only. Defender Aid clinic enrollment is limited to 8 students. If the registration is oversubscribed additional students will be placed on a waitlist. Completion of, or concurrent enrollment in, Criminal Procedure and/or Criminal Adjudication strongly recommended. 2L students entering their 4th semester may register upon email approval from Professor G. Smith.

⁹ Requires 3L standing and Administrative Law; there will also be an application and interview process.

¹⁰ Offered for a letter grade only. EPP enrollment is limited to seven (7) total students. Six (6) determined on a first come, first served basis by registration. The seventh will be the Student Director. If the registration is oversubscribed, additional students will be placed on a waitlist. With the following priority, (1) returning 3L students, (2) followed by 3L students, followed by 2L students who meet the prerequisites for the EPP. The prerequisites for the EPP are Trust & Estates prior to enrolling, plus either have taken or are currently enrolled in Professional Responsibility.

¹¹ 3L's have priority registration. Offered for a letter grade only. Limited to 6 students, with additional students placed on a waitlist for

consideration. Must have completed or be enrolled in Professional Responsibility. Recommended courses: Family Law, Dispute Resolution. **Note**: Students wanting to enroll in Bar Review <u>and</u> the Family & Child Advocacy Clinic should contact the Law Registrar for a special override.

- ¹² Requires 3L standing, offered for a letter grade only. Prosecution Assistance clinic enrollment is limited to 8 students; 7 determined on a first-come, first-served basis by registration. If the registration is oversubscribed additional students will be placed on a waitlist. Completion of Criminal Adjudication and Criminal Procedure is required beginning in the 2023-2024 academic year.
- ¹³ Offered for S/U credit ONLY. One credit per competition. Credit is given to student competitors in <u>approved</u> inter-school competitions. Please see our Law Registrar if you have any questions regarding which are <u>approved</u> competitions. Credit is applied in the semester <u>after</u> the student participates in the regional or national competition. The student must register for the credit and submit the form to receive credit. The required form can be downloaded from the Law School website.
- ¹⁴ Offered for S/U credit only. Students may NOT take a legal clinic in the same semester in which they participate in an extern program unless they obtain prior written permission from both the externship Faculty Director and the Clinic Director.
- ¹⁵ This course is a prerequisite for Advanced Estate Planning. There will be 1 makeup class scheduled on a Friday of Professor Delaney's choosing. Trusts and Estates is a prerequisite for this course.
- ¹⁶ This is a study abroad course to Chile during January 4-16, 2026. Contact Prof. Novogrodsky or Robison for additional details. Must be a 2L or 3L. If seats don't fill, 1L's may be allowed on a case-by-case basis and they may only take the course for S/U credit.
- ¹⁷ Independent Study is for writing in a specialized or advanced areas of the law. Students receive one credit hour for 50 hours of work or 2 credit hours for 100 hours of work. Grades are based on an independent study writing project. Students must submit a completed Independent Study form to our Law Registrar within one week after the start of the semester. The student must register for the credit and submit the form to receive credit. The required form can be downloaded from the website.
- ¹⁸ Independent Study: Clinic is meant to allow students to receive credit for continuing work completed in conjunction with a clinic or live practicum. To qualify for Clinic Independent Study credit a student must have completed at least one semester in a clinic or live practicum and must submit a form to the clinic or practicum instructor and our Law Registrar. The student must register for the credit and submit the form to receive credit. The required form can be downloaded from the website.
- ¹⁹ Offered for S/U credit ONLY. Requires Law Review Board membership.
- ²⁰ Trial Practice enrollment is limited to 16 students (per section if there is more than one) determined by a lottery, preference is given to third year students that have not taken Summer Trial Institute and then students who are going to be clinic directors. The Law Registrar will send out a link to sign-up for a place in the lottery, with a sign-up deadline of October 31 at 5:00 p.m.
