This article examines the historical underpinnings of and justifications for judicial rent deposit requirements, which predicate a tenant's ability to raise a habitability-related defense at trial on the tenant's ability to deposit with the court all funds allegedly owed to the plaintiff and argues that the requirements are functionally similar to a poll tax in placing an economic restraint on access to a democratic institution. It discusses the ways in which rent deposit requirements satisfy the underlying goals of eviction courts while undermining contemporary justice reform initiatives and the legitimacy of the courts. It proposes solutions for managing court dockets while allowing open access to the court.
