## Bookeye 5 Scanner



The law library is now the proud owner of a touchscreen state of the art scanner capable of quickly scanning multi-page documents with its attached feeder, or fragile books with its adjustable platform. Once scanned, you can edit the file and then save it to a USB drive, email it to yourself, create a QR code link, or store it online using an app. The scanner is available for your use in the reference area of the library, near the elevator.
