

Table of Code Provisions Affected by Novels, Edicts, & Appendices

This table should be self-explanatory for the most part. It is based upon data in a table created by Justice Blume listing the novels in order and showing the Code provisions he thought they affected. He also gave similar information in his notes to some of the novels. In cases where he was more specific in one place than in the other, I have listed here the most specific reference he made, e.g 1.2.14 instead of 1.2.

References are to novels unless otherwise indicated. Individual novel, edict, and appendix references are separated by semi-colons. Periods denote subdivisions, while dashes denote a sequence; e.g., 54.2—end indicates chapter 2 and all subsequent chapters of novel 54. Pr. stands for *principium*, the introductory section before a chapter; hdnt. means headnote, Blume's note preceding a provision; and nt. refers to his note following a provision.
