

## Table of Novels, Edicts, and Appendices Showing Code Sections Affected

This table is taken from one handwritten by Justice Blume in one of his notebooks. It varies from the original to the extent that I have: 1) used more specific references to Code sections affected when I found them in his Novels annotations; & 2) added relevant notes from those same annotations. The column on the left indicates the number of the novel, edict, or appendix (sometimes down to the section level), while the column on the right shows the Code provision he thought it affected.

Single dashes indicate a sequence (e.g., 2.1-.4 means novel 2, chapters 1 through 4), while two dashes with no following number indicate all subsequent chapters (e.g. 2.5-- means novel 2, chapters 5 to the end of the novel.). Pr. stands for *principium*, the introductory section before a chapter. Footnotes in quotes are Blume's.
