Cultural Competency The proposal clearly demonstrates a commitment to cultural competency through an exploration of the following: incorporating accessibility, including diverse perspectives, localizing curriculum, serving those disproportionately affected by the cost of course materials, and/or teaching across modalities that affect all students.		
Assessment The proposal incorporates assessment strategies for the project and how these curriculum changes will affect the quality of course materials and student learning outcomes.		
Impact to Open Education The proposal clearly describes course materials that will impact students and instructors across the field at multiple institutions throughout the state of Wyoming and/or addresses regional and disciplinary gaps in OER.
