Own the Journey in the New Year

Hello & Happy New Year!!

It's hard to believe we have started a new year. We hope 2025 was a happy one and that 2026 is an even better year for you. If last year wasn't so great, may your life's journey this year be a positive one.

We have a couple of important pieces of information to share with you in this newsletter. The School of Pharmacy is undergoing a curricular review with changes to the curriculum coming soon. Our chair of the curricular review, Dr. Jessica Richards, shares an update on the process for all to read. We also have a change coming soon to the Experiential Education Office. More information on that can be found below.

UW School of Pharmacy Curriculum Changes

In Fall 2023, the UW School of Pharmacy met with small groups of preceptors, alumni, and other stakeholders to help guide the process of our curricular review. We sincerely thank those of you who took time out of your busy schedules to share your insights on what we are doing well and where we can continue to improve. We would like to update you on the progress made since those meetings and outline our plans moving forward.

Following those initial sessions, we gathered additional input from faculty and students. The faculty then reviewed all feedback and data and determined that a full curricular redesign was the best path forward. A Curricular Redesign Taskforce was established and met biweekly from Fall 2024 through Spring 2025 to develop a comprehensive proposal.

Key elements of the proposal include:

- Transitioning courses such as medicinal chemistry, pharmacology, therapeutics, and pharmacy skills into an integrated model to better align content.
- Expanding instruction in drug information and literature evaluation.
- Incorporating and strengthening longitudinal curriculum threads, including pharmaceutical calculations.
- Adding key practice skills identified by preceptors and stakeholders.
- Introducing an additional Advanced Pharmacy Practice Experience (APPE) rotation in the fourth year.

The proposal was approved by the faculty in May 2025. The Taskforce is now finalizing the details, with an anticipated implementation date of August 2026.
