As we wrap up one year and get ready to start a new one, we thought it might be helpful to share a couple of resources pertinent to preceptors and various laws that impact precepting. We hope you find these suggested resources informative and helpful. According to Merriam-Webster.com, the meaning of experience (noun) "is direct observation of or participation in events as a basis of knowledge." Something personally encountered, undergone or lived through. Working in a pharmacy setting provides one with countless experiences. A possible outcome from one of these experiences could lead to harm to a patient resulting in legal action. Mistakes happen.

We are recommending an excellent CE authored by Dr. David B. Brushwood, R.Ph., J.D., Senior Lecturer, The University of Wyoming School of Pharmacy. *Dose of Defense: Raising Awareness of Legal Hazards in Pharmacy Precepting* is available free to all preceptors though CEIMPACT. Access to CEIMPACT is through your CORE account. See page 3 of this newsletter for directions and the access code. You will need your NABP E-profile ID number to receive reported credit, This CE discusses malpractice liabilities that could arise while having a Pharmacy student on site. The CE provides several legal cases and risk management strategies to reduce exposures to malpractice liability.

Another relevant CE for preceptors also available through CEIMPACT is, *FERPA: A Guide for Preceptors*. As a preceptor affiliated with an education institution that receives federal funds, FERPA is the law that applies to your interactions with the students you are precepting. This CE offers applicable scenarios and their relevance to you as a pharmacy preceptor and the educational record.




