


### PHCY 5244 State Regulation of Health Professions

### 2 Credit Hours

### **Background:**

While federal agencies such as the Food and Drug Administration (FDA) and the Drug Enforcement Administration (DEA) *primarily* regulate various aspects of the pharmaceutical product, it is state agencies that *primarily* regulate health care practitioners and the clinical sites where practitioners deliver health care to patients. Changes in regulation can produce changes in the quality of health care. Collaboration between those who regulate the pharmaceutical product, and those who regulate professionals who use pharmaceutical products, is necessary to promote beneficial outcomes from pharmaceutical care.

### **Course Description:**

Focusing primarily on the pharmacy profession as an example of a regulated professional group that serves the public interest, this course examines how state regulatory agencies assure the initial competence of practitioners, as well as their continuing competence in the years following the completion of academic professional training. The course also examines the factors that are applied to the regulation of health care settings, such as clinics, pharmacies, hospitals, and long-term care facilities. Using the structure-process-outcomes typology of Avedis Donabedian, the course examines how state regulators can try to ensure that adequate structures and useful processes are employed by health care practitioners in order to promote positive public health outcomes.

### **Course Purpose:**

The purpose of this course is to provide the student with expertise in the area of compliance with state-level health regulations that are intended to protect patients from avoidable harm and protect health care professionals and institutions from non-compliant practices that can lead to adverse regulatory consequences.

### Place and Time of Class Sessions:

This is a condensed course that will be taught over a five week period. Live courses will be taught on Sundays, beginning at 5PM Mountain Time, through Big Blue Button. Learning materials will be posted on WyoCourses and may be accessed at any time. There will be five exams that will start at 7am on Fridays and will end at noon on Sundays.
