Who is eligible to enroll?

All registered non-international undergraduate students enrolled in 12 or more credit hours, students in the WWAMI program and graduate students including, Students at the University of Wyoming/Casper College, Teton Science School and those in the Doctor of Nursing Practice (DNP) program enrolled in 9 or more credit hours are eligible to enroll in this Insurance Plan at the time of registration. Undergraduates taking 6 to 11.5 credit hours and graduate students taking 4.5 to 8.5 credit hours are eligible to enroll in this Insurance Plan and the part-time benefit fee package at the time of registration. Graduate students who are otherwise eligible for the part-time benefit package are eligible to enroll in this Insurance Plan. Undergraduate and graduate students taking summer classes must be enrolled in 3 credit hours over this period to be eligible to enroll in this Insurance Plan. Students in the Bachelors Reach for Accelerated Nursing Degree (BRAND) and those who are in their final Pharmacy semester rotations, who meet the credit hours requirements are also eligible.

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements that the student actively attend classes. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

Exclusions and Limitations

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

- 1. Acne.
- 2. Acupuncture.
- 3. Addiction, such as:
 - Caffeine addiction.
 - Non-chemical addiction, such as: gambling, sexual, spending, shopping, working and religious.
 - Codependency.
- 4. Behavioral problems. Learning disabilities.
