2. Dr. Mariela Srednik: "Antimicrobial Susceptibility, Antimicrobial Resistance, Virulence Genes, and Phylogenetic Analysis in Isolates Obtained from Tularemia and Plague Animal Cases in Wyoming." - BAT

3. Dr. Takashi Suyama- "Biocatalysis for discovery and synthesis of bioactive metabolites" rDNA and BAT

Suyama was not present. Committee viewed the This project will be working with E. coli and Pichia at a BSL-1 level. Some comments made by committee. Main comment was the level of containment for the lab. While some agents are risk group 2 the PI indicated he would work with the agents at a BSL-1 level lab. Goodnight plans to inspect the facility to ensure proper measures are in place for a BSL-2 level lab.

Motion by Perry to approve protocols pending modifications of a successful BSL-2 facility inspection by Goodnight. Seconded by Steinkraus. The motion passes unanimously.
