#### **SER Executive Director Report**

#### Overview and Updates - Holly Krutka

Executive Director Krutka provided an overview of the proposed budgets for FY26, including the standard budget, exception funding, and the Wyoming Integrated Test Center (ITC). She also provided a summary of the proposed goals for each unit in SER.

SER's FY26 budgetary approval request included authority to spend:

- The SER standard budget of \$10,553,904
- Exception funding, including permission to fully expend the first allocation of nuclear funding and access the second tranche of nuclear research funding, as well as permission to access existing exception funding to conduct the research, design, and detailed engineering of the solvent extraction field demonstration project, in the amounts from the exceptions funds previously appropriated as follows:
  - 1. FY23 Hydrogen Center of Excellence: \$67,013
  - 2. FY23 Nuclear Energy Collaboration (Allocation 1): \$258,906
  - 3. FY24 Carbon Engineering/Research & Solvent Extraction Detailed Design: \$1,750,000
  - 4. FY24 Mowry: \$729,667
  - 5. FY25 Carbon Engineering/Solvent Extraction Field Demonstration Plant: \$3,150,000
  - 6. FY25 Nuclear Energy Collaboration (Allocation 2): \$1,300,000
  - 7. FY25 Lithium Extraction Competition/XPRIZE: \$250,000
- The ITC FY26 budget totaling \$1,101,310

**Motion** - Peter Gottfried made a motion to approve the proposed FY26 standard budget. David Emery seconded the motion.

The motion was approved without objection.

**Motion** - David Emery made a motion to approve the spending of exception funds in FY26, utilizing \$7,505,586 (subtotals above) of exception funding. Peter Gottfried seconded the motion.
