2026-2027 Cost of Attendance (COA) Adjustment Appeal

The Cost of Attendance (COA) represents a realistic estimate of the costs associated with attending the University of Wyoming (UW). If you believe that the standard COA does not accurately reflect your basic educational expenses, you may submit this COA Appeal. If your appeal is approved, you could receive additional loan funds. Due to annual and aggregate loan limits, it is possible that your eligibility could be restricted to a Parent PLUS Loan/Graduate PLUS loan and/or private education loan. Please be aware that the University of Wyoming's Office of Scholarships & Financial Aid does not award or increase institutional aid for COA adjustments.

If you are ONLY requesting a Cost of Attendance adjustment to allow for the purchase of a computer, you should complete the 2026-2027 One-Time Computer Allowance Adjustment Request Form instead.
