



## 2026-2027 Unaccompanied Homeless Youth Verification

This form is used to verify that you are, or were, an unaccompanied youth who was homeless OR an unaccompanied youth providing for your own living expenses who is at risk of being homeless. "Homeless" means lacking fixed, regular, and adequate housing (includes living in shelters, motels, autos, or temporarily living with other people because you had nowhere else to go). "Unaccompanied" means you are not living in the physical custody of your parent or guardian. "Youth" means you are 21 years of age or younger still enrolled in high school as of the day you sign the Free Application for Federal Student Aid application (FAFSA).
