Federal Shutdown Update:

- 1. So far, still receiving reimbursements. Monitoring closely. A lot of employees paid part- or full-time on federal funds.
- 2. No one is affected at this time. A process is in place if funds go dry to put them on temporary funds until the government opens.

FIRST Committee – Foreign Influence Risk Safety and Travel:

- PRWORA federal public benefits from five federal agencies. Requires we verify eligibility to receive federal benefits (US citizen or authorized legal immigrant).
 Website has process. Requesting compliance by units by December 1. Example units affected: medical outreach serving non-citizens, 4H extensions servicing nonimmigrants.
- 2. USDA restrictions Dept. of Agriculture affected. Cannot apply for USDA grant going forward if you have any agreement with a country of concern (ie. as China, Russia, Cuba, North Korea, etc.). If you have a student in your lab that is from one of these countries of concern, you no longer qualify for federal funds.
- 3. Foreign Influence policies in general.
- 4. Travel guidelines for safety going to select countries (tracking system). Duty to Care. Need knowledge of where UW students, staff, faculty are going so can assist in getting them out in emergencies. Looking into purchasing travel management programs to assist. Timeline TBD
 - a. Student travelers stopped at customs? Highly recommend any student who is leaving the country who is not an American citizen should first consult International Students and Scholars for the risk and effects on their Visa.
 - b. If an American student is detained, call Global Studies and the US Embassy.

Standard Administrative Procedure (SAP)

- 1. Eighty regulations (down from over 100)
- 2. Policies (currently over 1000) looking to make a shorter list. Currently at a pause for non-critical policy updates.

OCR Office of Civil Rights

- Found in violation of OCR due to our partnership with "The PhD Project" in their recruitment of "students of color" (even though we did not request that portion of their services). Stopped membership with that group.
- 2. Now we must provide a list of all 60 memberships/partnerships so we can be sure none are preferential.
