A RESOLUTION TO ALLOW UNIVERSITY OF WYOMING BOARD RETIREES TO ENROLL IN UNIVERSITY COURSES ON A SPACE AVAILABLE BASIS AT NO COST.

1	WHEREAS, Staff Senate believes the University should always find opportunities to
2	promote life-long learning; and
3	WHEREAS, the University's Wyoming Senior Citizen Policy states that citizens, age 65
4	and over who have been admitted to UW, currently can take classes on a space available basis at
5	no cost upon presentation of evidence of age and Wyoming residence prior to the beginning of
6	the term in which classes will be taken; and
7	WHEREAS, the University honors employees who have 25 years of service or are age 60
8	with 15 years of service as board retirees with additional retirement benefits; and
9	WHEREAS, currently board retirees who have not reached the age of 65 cannot take
10	advantage of the Wyoming Senior Citizen Policy;
11	THEREFORE BE IT RESOLVED that both current University board retiree benefits and
12	the University's Wyoming Senior Citizen Policy be revised to offer board retirees, no matter
13	what age, the benefit of attending University classes on a space available basis at no cost.
